Describe Cause of Problem and Remedial Action Taken.*

Leak reported by public (employees of American Machine at 211 S. Leech) on flow line at South Hobbs Unit Well #225. Well was immediately turned off and valves were shut on wellhead and header that are on the same location at the intersection of Leech and White Streets in Hobbs, NM. All fluid was contained by west curb on Leech Street. Fluid ran along curb to the north and stopped at corner of Leech and Dunnam. There was no city drain along this block and we were able to recover all fluid.

Describe Area Affected and Cleanup Action Taken.*

Spilled fluid ran along curb for about a city block, north to the corner of Leech and Dunnam. There is no city drain on this corner and all fluid was recovered via vacuum truck. A transport truck loaded with fresh water was called and entire area was over flushed to vacuum truck on the corner of Leech and Dunnam. All rinse water and spilled fluid was recovered and hauled to an approved disposal. Piping will be excavated and repaired. Due to minimal fluid loss and damage, no further work is planned at this site. This report being sent, for information only, due to public report of spill.
