This is a request for administrative approval for an unorthodox gas well location in the Blanco Mesa Verde pool.

It is intended to locate the El Paso Natural Gas Company's Dawson #1A at 640' from the North line and 985' from the West line of Section 31, T-31-N, R-8-W, San Juan County, New Mexico.

A canyon power line and pipeline in the northwest corner of this short section makes it impossible to build an orthodox gas well location.

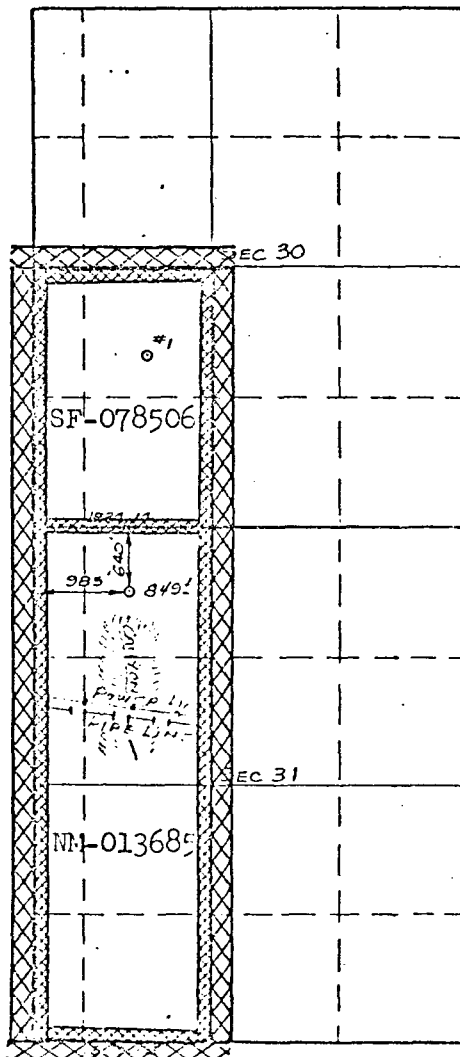

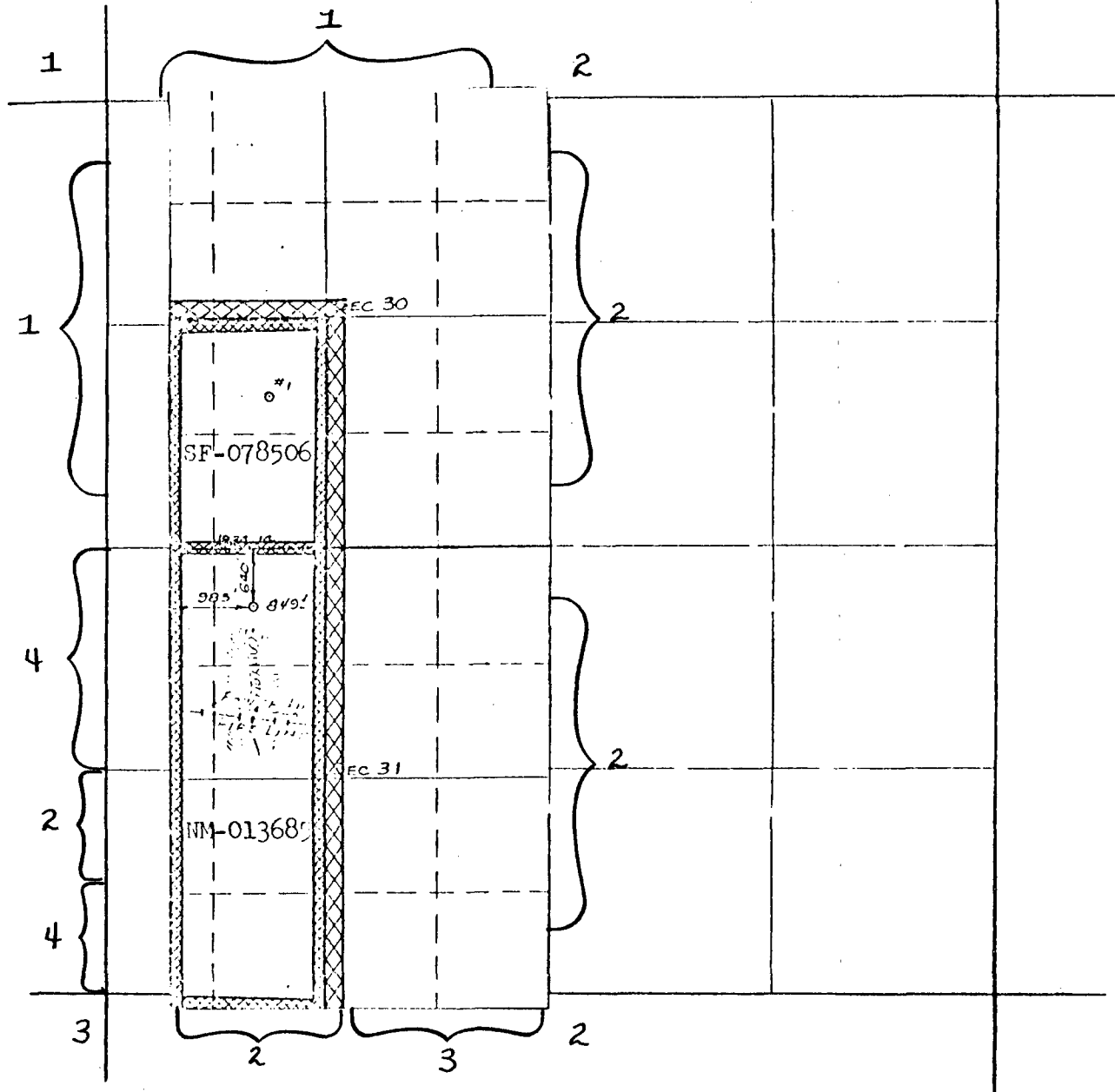
