Present condition:

PBTD 6880. 95/8" 36 and 40# J-55 8 rd thrd casing cemented at 2990 with 500 sacks. 7" 23 and 26# J-55 8 rd thrd casing cemented at 7210 with 300 sacks. 7" casing cut out from 6728 to 6770. Abandoned as water injection well 2-1-62. Well has been temporary abandoned 2-1-62 to date. It is now proposed to plug back and recompleat in Mesa Verde zone as follows:

Cement plug will be spotted over cut in 7" casing up to 6650. A bond log will be run to find top of cement outside of casing. After finding top of cement, casing will then be cemented to top of Alamo at 2490.

9# mud will be spotted in 7" casing 6650 to 5585. A 100' cement plug will be spotted 5585 to 5485.

Mesa Verde zone will be perforated and fractured to stimulate production.

A pit 20 X 20 X 4' deep on existing location to contain frac water while cleaning up and testing. After completion location will be cleaned up, pit covered and distured area will be reseeded to within 5' of all facilites with BLM approved seeding program.

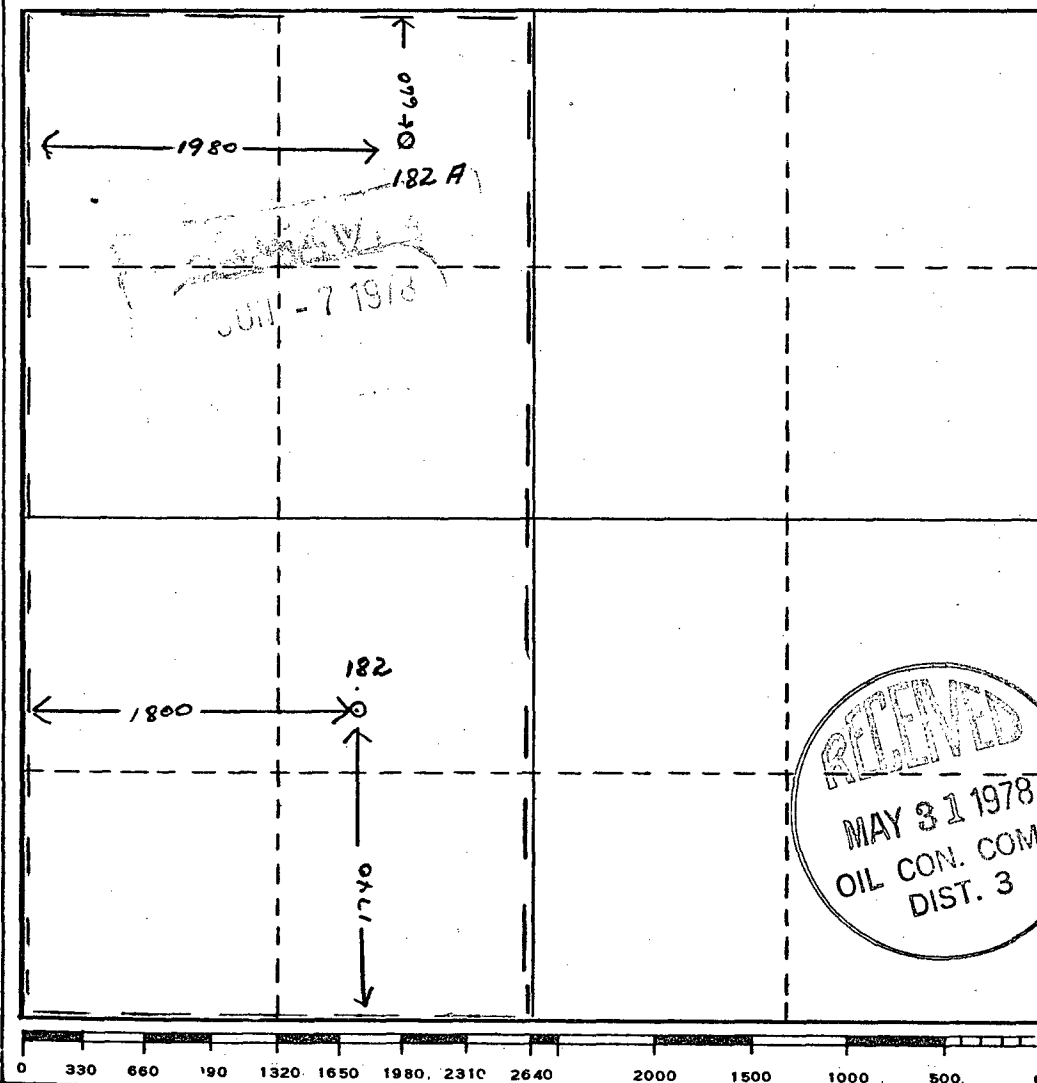

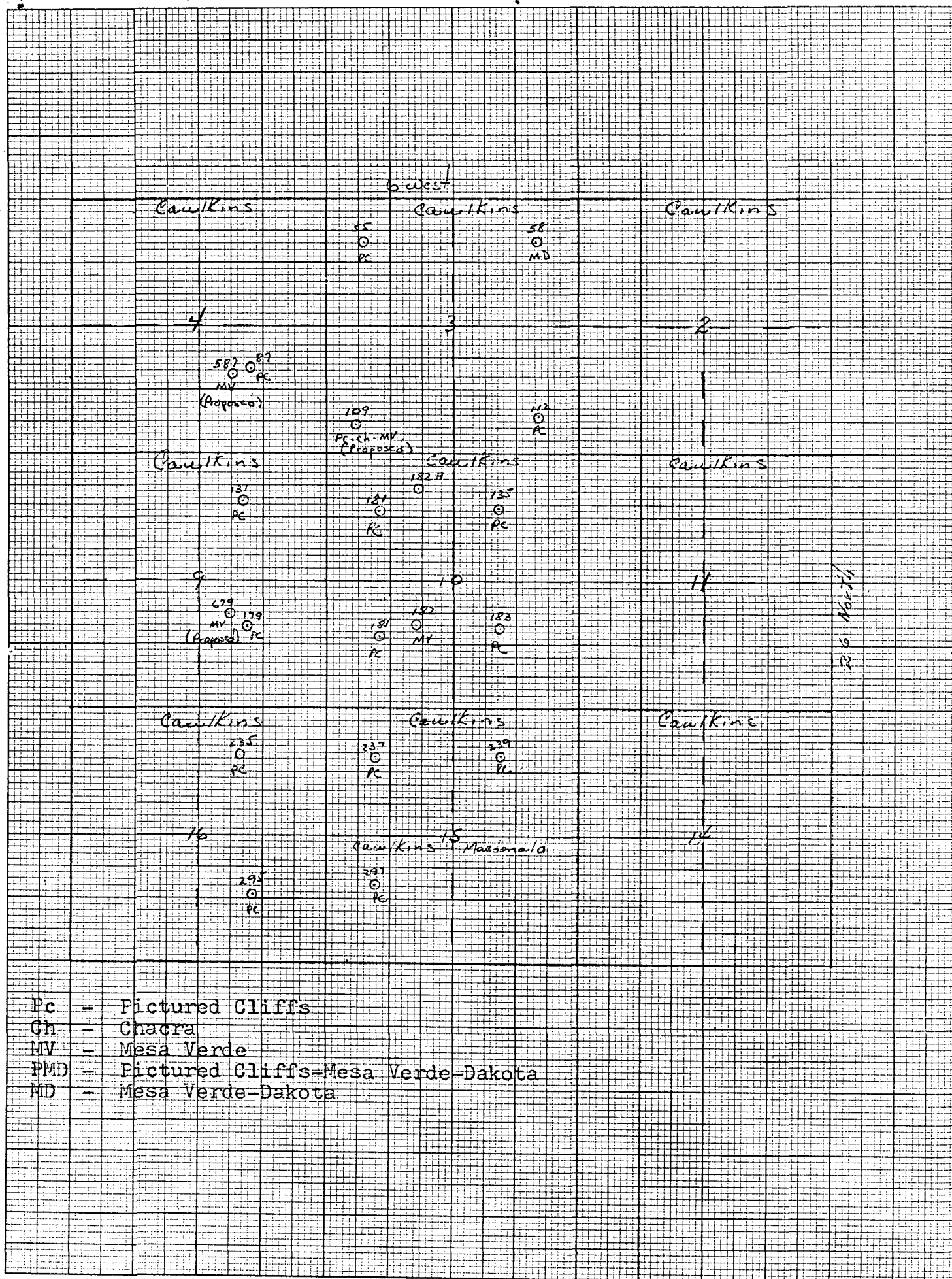
