Dear Sir:

Delta Drilling Company is preparing to drill the captioned well at a location 2,032' FEL and 1,722' FSL of Section 14-T23S-R28E, NMPM, Eddy County, New Mexico. It was our initial intent to stake this location 1,980' from the South and East lines of the Section. However, a pad constructed at this latter location would cover a portion of a partial concrete irrigation ditch which runs in the northeasterly direction across the SE4 of Section 14. In addition, the aforementioned irrigation ditch is used for terraced irrigation in a southeasterly direction from the ditch itself. Consequently, it was necessary to move the location south and west to prevent the destruction of a portion of the irrigation ditch and the terraced irrigation area.


