

Atlantic Richfield Company requests a hearing to apply for simultaneous dedication of a previously approved 160 acre <sup>NW/4 Sec 31</sup> Eumont Gas Proration Unit to two wells, the J. R. Phillips "B" Nos. 5 and 6. This unit is currently classified as marginal with all acreage dedicated to the J. R. Phillips "B" No. 5.

Futhermore, Atlantic Richfield Company requests approval of an unorthodox location and a non-standard proration unit for the subject well. In addition, Atlantic Richfield Company feels that an infill location is necessary to efficiently drain the subject acreage and would like certification of the same.

This well was drilled and completed as an oil well in the Eunice Monument pool in 1974 at an unorthodox location of 990' FNL and 1650' FWL of Section 31-T19S-R37E, in Lea County, New Mexico. We plan to abandon the Eunice Monument zone in the well and recomplete in the Eumont Gas pool.

Atlantic Richfield Company believes approval of these requests will be in the interest of conservation, protect correlative rights, and allow for more complete recovery of Eumont gas reserves.



The Division has indicated that the subject well will meet the requirements for administrative approval in applying for simultaneous dedication of a previously approved 160 acre Eumont Gas Proration Unit to two wells, the J. R. Phillips "B" Nos. 5 and 6. This unit is currently classified as marginal with all acreage dedicated to the J. R. Phillips "B" No. 5.

The original application, filed by letter on January 25, 1979, requested a hearing to approve an unorthodox location and a non-standard proration unit for the subject well in the Eumont Gas Pool. This well had been drilled and completed as an oil well in the Eunice Monument Oil pool in 1974 at an unorthodox location of 990' FNL and 1650' FWL of Section 31-T19S-R37E in Lea County, New Mexico. We plan to abandon the Eunice Monument zone in the well and recomplete in the Eumont Gas pool.






