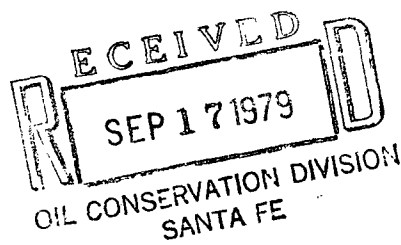

By this verified application submitted in triplicate, Amoco requests approval of an unorthodox location for its Kelly Gas Com "D" No. 1 to be located 560' FWL and 2010' FSL of Section 12, T30N, R12W. Permissible location for an Aztec Pictured Cliffs well must be at least 790' from the outer boundary line of the 160-acre proration unit.

The reason for the unorthodox location is topographical. There is an irrigated field running through the middle of the SW/4 of Section 12 and also a precipitous cliff. The unorthodox location selected is therefore on a bluff.

By the attached Verification and Affidavit that is a part of this application, all affected offset operators are being notified by certified mail of this unorthodox location request.
