Subject well was approved for a Morrow test at an unorthodox location by Order No. R6146, Case 6681. The well was not commercial in the Morrow and intermediate formations, but made an oil producer in the Yeso formation, probably an extension to Penasco Draw Yeso, San Andres.

The location is 660' FSL and 1100' FWL. We are asking that the non-standard location be approved for Yeso and San Andres completion under the provisions of NMOCD Rule 104F. A lease ownership plat is attached hereto. East offset is within the Working Interest Unit Area.


