Gallegos Canyon Unit Well No. 93E located 1725 feet from the South line and 590 feet from the West line of Section 36, Township 29 North, Range 12 West;

Gallegos Canyon Unit Well No. 173E located 635 feet from the West line and 1925 feet from the North line of Section 29, Township 29 North, Range 12 West;

Gallegos Canyon Unit Well No. 174E located 1450 feet from the North line and 410 feet from the West line of Section 28, Township 28 North, Range 12 West;

- Gallegos Canyon Unit Well No. 184E located 400 feet from the South line and 630 feet from the East line of Section 28, Township 28 North, Range 12 West;
- Gallegos Canyon Unit Well No. 185E located 825 feet from the North line and 775 feet from the East line of Section 33, Township 28 North, Range 12 West; and
