

Well Location, Chaves County, New Mexico

Gentlemen:

Boyd Operating Company hereby makes application for administrative approval of the unorthodox location of its Blakemore Federal Well No. 1 located 600 feet from the North and West lines of Section 20, Township 9 South, Range 26 East, N.M.P.M. Chaves County, New Mexico. This well was originally drilled at an orthodox location projected to the Granite Wash. The Granite Wash was not productive of hydrocarbons in commercial quantities and we, therefore, have plugged back and recompleted this well in the Wolfcamp. Our request for administrative approval of this unorthodox location, therefore, results from the recompletion of a well which was previously drilled to another horizon. It was a standard location for the original horizon.

Enclosed are copies of a plat showing the ownership of all leases offsetting the subject unit and all wells located thereon. The only offset operators are Pennzoil and Margene Blakemore Trust. All offset operators have been notified of this application by certified mail and copies of their waivers are attached to this application.

Boyd Operating Company requests that this application be expedited to the fullest extent possible.


