

Re: Unorthodox Location - Galleges Canyon Unit Well No. 305

Gentlemen:

Energy Reserves Group, Inc., requests approval of an unorthodox location on its well Gallegos Canyon Unit #306.

The site as proposed is located 2,015' FSL and 830' FEL Sec. 19-T29N-R12W. The purpose of this request is for topographic reasons. The location lies on top of a hill between two existing wells (ERG's GCU #300 on the West and Amoco's GCU #110 E on the East). Very little additional surface disturbance will be required. It also lies due North of the Bloomfield highway which would prohibit moving the location South. The land South of the highway in Sec 19 is predominantly private. ERG would expect considerable difficulty and expense obtaining landowner approval to drill in this

Amoco Production Company is the operator of the Gallegos Canyon Unit with Energy Reserves Group, Inc., as the sub-operator of the Pictured Cliffs with negotiations underway to obtain Fruitland operating rights as well. See attached plat of the proposed well location.


