This is a request for administrative approval for a non-standard gas well location in the Otero Chacra and Blanco Mesaverde pools.

Burlington Resources intends to recomplete the Lively #18E Basin Dakota well, add the Otero Chacra and Blanco Mesaverde pools, and downhole commingle the three under Order DHC-2795. Order NSL-1210 was issued for the Basin Dakota.

Production from the Otero Chacra is included in a 160 acre gas spacing unit comprising of the northwest quarter (NW/4) of Section 1. Production from the Blanco Mesaverde is included in a 321.5 acre gas spacing unit comprising of the west half (W/2) of Section 1. Production from the Basin Dakota is included in a 321.5 acre gas spacing unit comprising of the west half (W/2) of Section 1 and is to be dedicated to the Lively #18 (30-045-21326) located at 800'FSL, 1800'FWL in Section 1.


