Describe Cause of Problem and Remedial Action Taken.* Water leg on heater treater broke apart releasing production fluid.

Describe Area Affected and Cleanup Action Taken.* Area affected was immediately around heater on the battery pad to the south and a pooling area just south off the battery pad which measures approximately 27' wide by 105' long and penetrated to a depth of approximately 6". The NM OCD site ranking scale measures this release at "Site rank Total", equals 10 points. Marathon Oil Company has removed approximately 200 yards of top soil and taken the soil to Sundance Disposal near Eunice, NM. All stained soil shall be removed and/or remediated until the soil meets the NM OCD regulations. Once the soil has dried out enough from the recent rains to take adequate soil samples, said samples will be taken, sent to Cardinal Laboratories, with copies of the results sent on to the NM OCD office for a final closure evaluation.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
