The above named company is hereby authorized to commingle, measure and sell off-lease Basin-Fruitland Coal (Gas - 71629) Pool production from the following described area ("commingled area") lotated in San Juan County, New Mexico. This area comprises all of parts of Federal Leases No. NM-101058, NM-104606, NM-100805, NM-100806, NM-100807, NM-015654, all of parts of Navajo Allotted Leases No. NOG-9910-1363, NOG-9911-1369, NOG-9910-1365, NOG-9911-1367, NOG-0101-1426, NOG-0101-1427, and all or parts of State of New Mexico Leases No. B-10889 and VO-5292:

Production from these gas wells shall be gathered, commingled and sold through a CDP Meter (Enterprise Meter No. 98-708-01) located in the NW/4 NW/4 of Section 10, Township 24 North, Range 10 West, NMPM. Individual well orifice flow meters shall be installed and gas sales shall be allocated based on these individual meters. Water and condensate production shall be separated at each well.

There are currently thirty-one (31) wells within the subject area that are proposed to be commingled. Additional wells located within the commingled area that are producing from the Basin-Fruitland Coal Gas Pool may be added to this gas gathering system in the future without additional notice to the interest owners within the commingled area. To add additional wells, the applicant shall notify the Santa Fe Office of the Division either by sundry notice or letter. Administrative Order No. CTB-528-A (oleman Oil & Gas, Inc. NOTE: This installation shall be installed and operated in accordance with the applicable Division rules and regulations. It is the responsibility of the producer to notify the transporter of this commingling authority.

FURTHER: The operator shall notify the Aztec district office of the Division prior to commingling.
