



Amoco Production Company hereby requests administrative approval for an unorthodox well location for the Storey "C" #2M well in the Blanco Mesaverde and Otero Chacra Pools. Amoco plans to recompleate this well to the Blanco Mesaverde and Otero Chacra formations then commingling those formations with the existing Basin Dakota formation. We have recently filed an application with the NMOCD for downhole commingling in this well following the recompletions. The spacing unit for this well is the W/2 Section 35 in the Blanco Mesaverde and the NW/4 Section 35 for the Otero Chacra. The unorthodox location for the Blanco Mesaverde and Otero Chacra formations is sought due to the well being less than the required 790' to any outer boundary.

A copy of this application will be submitted to the offset operators by certified mail with a request that they furnish your Santa Fe office with a Waiver of Objection, and return one copy to this office. Attached are plats showing the location of the well, offset operators, and all wells drilled in the area.
