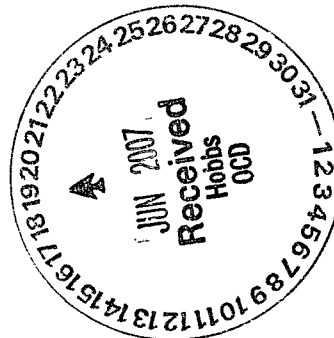

Sport Environmental Services, on behalf of Yates Energy Corporation, submits this preliminary delineation work plan for the aforementioned Reddy-Gulf State No. 002 site.

Preliminary Mitigation Activities and Delineation Information

On May 16, 2007, Sport Environmental Services visited the Reddy-Gulf State Lease. The initial site investigation consisted of site photographs taken of NMOCD addressed items of concern (refer to *Exhibit A*.)

Yates Energy Corporation has performed limited clean-up at the wellhead. To prevent recurring releases, a new stuffing box was installed and a new polish liner put in place. Additional clean-up is still required and will commence once approved by the NMOCD.

Extensive sampling will not be conducted prior to the initial removal of visually contaminated soils. Soils which appear to be visually contaminated are scheduled to be excavated and stockpiled on a 20 mil liner located on-site. Soils are to be excavated with the use of a small gang performing hand digging due to proximity to the wellhead. Upon completion of soils excavation, analytical delineation will take place.

In conjunction with the removal of visually contaminated materials, a Soil Investigation, Risk Assessment and Sampling Plan will be prepared for NMOCD approval. The Sampling Plan will be designed to verify

a clean buffer perimeter and to address the potential of groundwater impact. The fate of the materials will be determined based upon analytical characteristics and NMOCD approval.

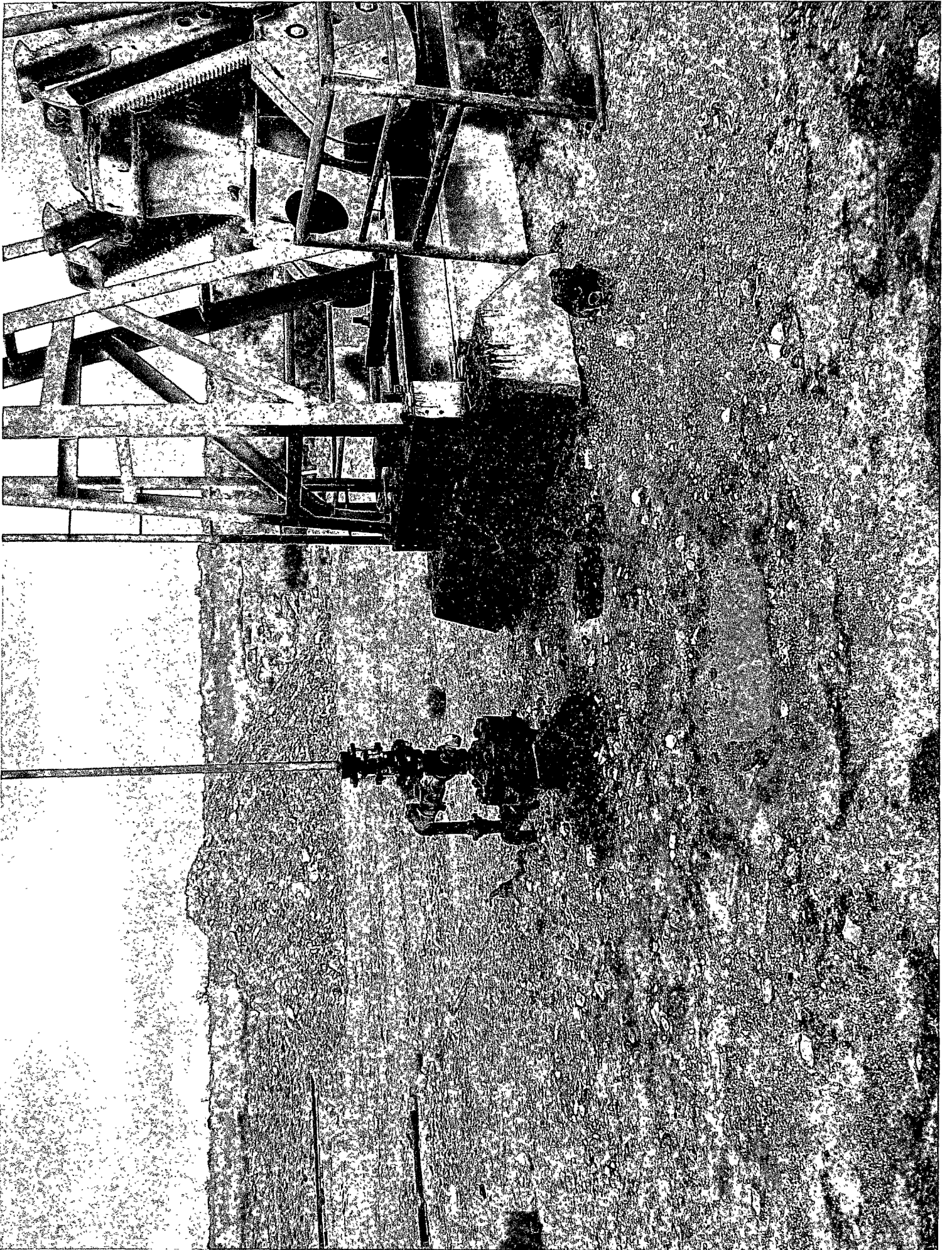
