

Anadarko Production Company requests administrative approval to drill the Ballard Grayburg San Andres Unit <u>Well No.19-2</u> at an unorthodox location 1700 feet from the south line and 1000 feet from the east line of Section 7, Township 18 South, Range 29 East, Eddy County, New Mexico. An application to drill this well wassfiled June 29, 1982.

The Ballard Grayburg San Andres Unit waterflood was authorized March 16, 1973 by Order Number R-4493. Paragraph 6 of this order provides for administrative approval of such orthodox locations.

The proposed well will be completed as an infill producer in the Grayburg formation. The location is 320 feet from the quarter-quarter line, therefore making it unorthodóx. However, the well will be located further than 330 feet from the unit boundary. This well is needed to recover waterflood oil not obtainable by existing wells.

Attached is a C-102 form for the proposed well. Thank you for your consideration in this matter.
