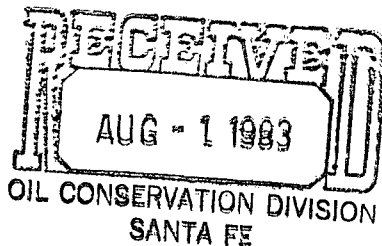

Yates Petroleum Corporation would appreciate an administrative approval for a proposed unorthodox Upper Penn oil well location as provided for under NMOCD Rule 104F.

This well was originally drilled by Cactus Drilling Corp of Texas. At the time it was drilled, there was no designated field in this area. We are proposing to reenter this well and deepen approximately 350'. Therefore, we are applying for a non-standard location approval.
