

Dear Sir:

Anadarko Production Company requests administrative approval to drill two infield producers at unorthodox locations within the unit boundaries of the Langlie-Mattix Penrose Sand Unit, T22S-R37E, Lea County, New Mexico. The legal description of each of the proposed wells is as follows:

- 1) LMPSU #13C-12, 110' FNL & 2580' FWL, Sec 27, T22S-R37E
- 2) LMPSU #21-9, 1425' FNL & 1425' FWL, Sec 34, T22S-R37E.

*Langlie-Mattix
Penrose Pool*

Each of the two locations are further than 330 feet from a lease boundary but are closer than 330 feet from a quarter-quarter line and/or a section line.

Anadarko Production Company is currently active in developing the Langlie-Mattix Unit and believes that the drilling of two wells at the proposed locations will recover commercial quantities of secondary oil otherwise not recoverable at current operations. Two additional wells, one penrose producer and one flood observation well, are also being permitted at this time. Because of orthodox locations for each of the above mentioned wells, applications for permits to drill have not been included with this correspondence.

Enclosed is a copy of notification sent to offset operators as well as confirmation of receipt of such notice. Also included are certified C-102 forms for each well mentioned, and a plat of the Langlie-Mattix Penrose Sand Unit with proposed locations for each well indicated.
