FOURTH AMENDED AGREED COMPLIANCE ORDER

Pursuant to Ordering Paragraphs 3 and 4 of Agreed Compliance Order 108 as amended by Amended Agreed Compliance Orders 108-A, 108-B and 108-C, the Director of the Oil Conservation Division (OCD) hereby amends that Order as follows:

FINDINGS

- 1. Agreed Compliance Order 108 as amended requires Yates Petroleum Corporation (Operator) to return to compliance with OCD Rule 201 by August 10, 2007 at least one of the wells identified in Exhibit A not identified in Findings Paragraph 3 of ACOI 108-B or Findings Paragraph 3 of ACOI 108-C to meet its 18-well goal for this period, and file a compliance report by August 10, 2007.
- 2. ACOI 108 as amended further provides that if Operator returns to compliance with OCD Rule 201 by February 10, 2007 at least one of the wells identified in Exhibit A not identified in Findings Paragraph 3 of ACOI 108-B or Findings Paragraph 3 of ACOI 108-C, and files a timely compliance report, upon verification of the report the OCD shall issue an amendment extending the terms of ACOI-108 for an additional six-month period, requiring Operator to return an additional 18 wells to compliance by that deadline. If Operator exceeds its compliance goal in any period, the excess wells shall count towards its compliance goal for the subsequent period(s).
- 3. Operator filed a timely compliance report, and the OCD has verified that Operator has returned to compliance the following wells identified in Exhibit A not identified in Findings Paragraph 3 of ACOI 108-B or Findings Paragraph 3 of ACOI 108-C:

CONCLUSIONS

- 1. Operator has returned to compliance 24 wells identified on Exhibit A not listed in Findings Paragraph 3 of ACOI 108-B or Findings Paragraph 3 of ACOI 108-C, exceeding its one well goal for this period and exceeding its 18-well goal for the final period of the Order.
- The OCD should amend ACOI-108 to extend its terms through February 10, 2008.

The terms of ACOI-108 as amended remain in effect and are extended 1. through February 10, 2008.
