By copy of the attached letter and attachments, offset leaseholders were notified of this request for a well location exception by certified mail.

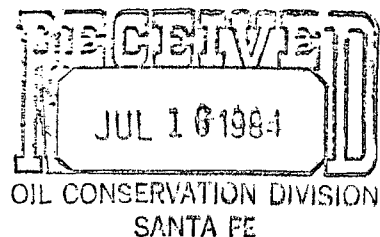
