

Gentlemen:

The undersigned hereby applies for an unorthodox location at the above described site. Please note that you have previously approved an unorthodox location for this well at a site 880' from the South line and 230' from the West line of the same Section, Township and Range by your Administrative Order NSL-1992. We have had to move the location of this well due to unreconcilable differences with the surface owner.

The well is within the city limits of Farmington, New Mexico. Topography and a City of Farmington ordinance requiring Six Hundred Sixty Feet (660') between any oil and gas well and the high water mark of Lake Farmington require the unorthodox location.
