Mr. Williams:

As discussed with you earlier, Basic has completed the excavation phase of the remediation at P & S Brine. Basic has hauled approximately 2700 cu. yds. of salt contaminated soil to Sundance for disposal. The excavated area was sampled from the beginning of the spill going East approximately 1600 ft. We took 22 different composite samples after taking approximately 1 ft. of soil from the spill area. When the results of the samples were received, there were areas which required additional excavation. We excavated additional soil from areas 1, 2, 7, 8, 9, 10, 14, 15, 16 and 20. These areas were retested and were within the range the OCD would accept. As recommended by OCD, we installed a clay liner in areas 5, 6, 1 and 2. This was being completed as verbally approved by Mr. Chris Williams. Basic would like to continue the closing of the site as approved. We will backfill, level and caliche areas as needed.

We will file a final report of the closing with new C-141. Find enclosed analytical and photos of work.
