Mobil Producing Texas and New Mexico Inc. is requesting administrative approval for unorthodox locations on the following wells:

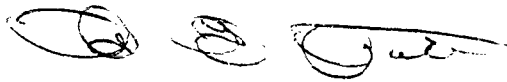

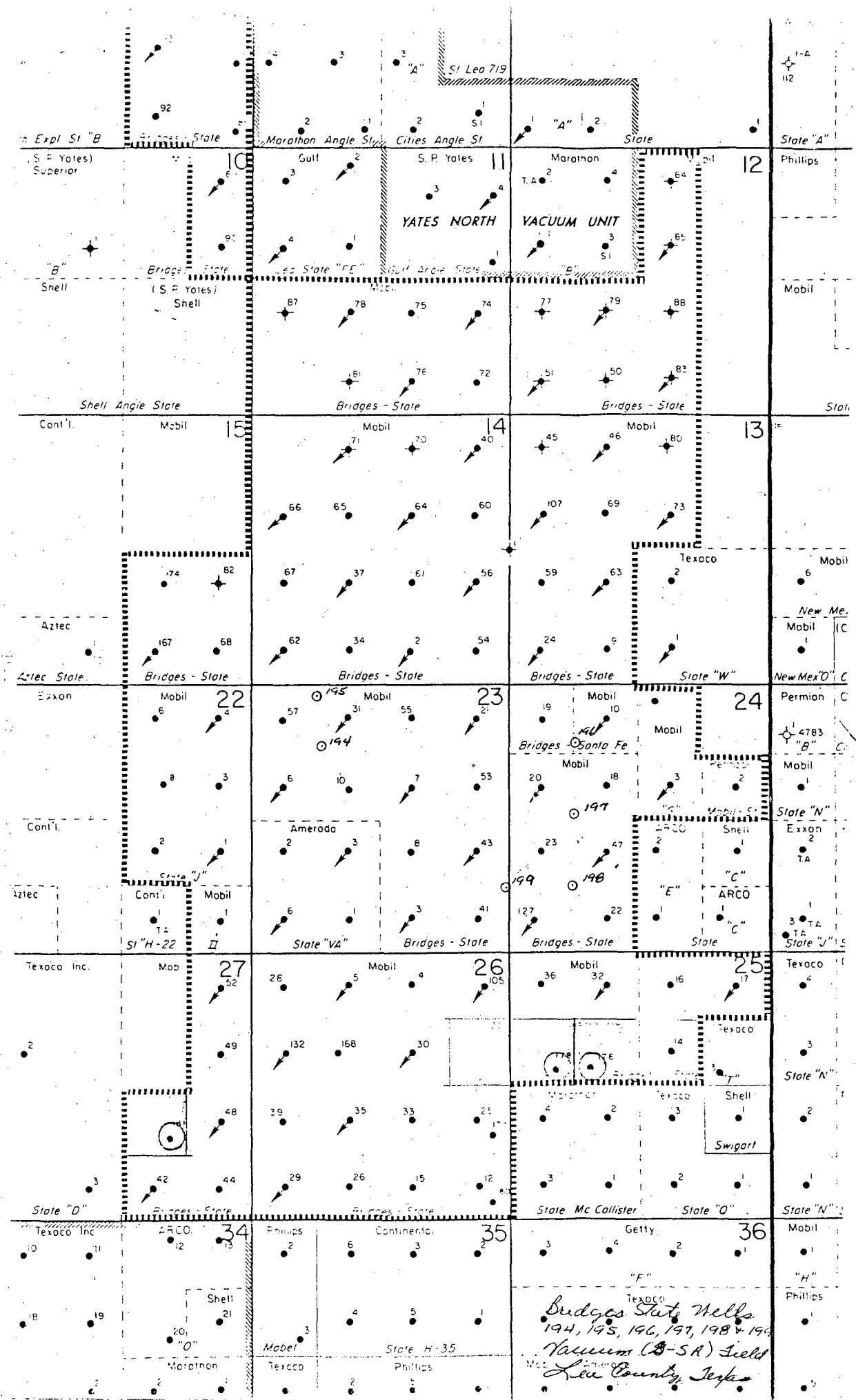

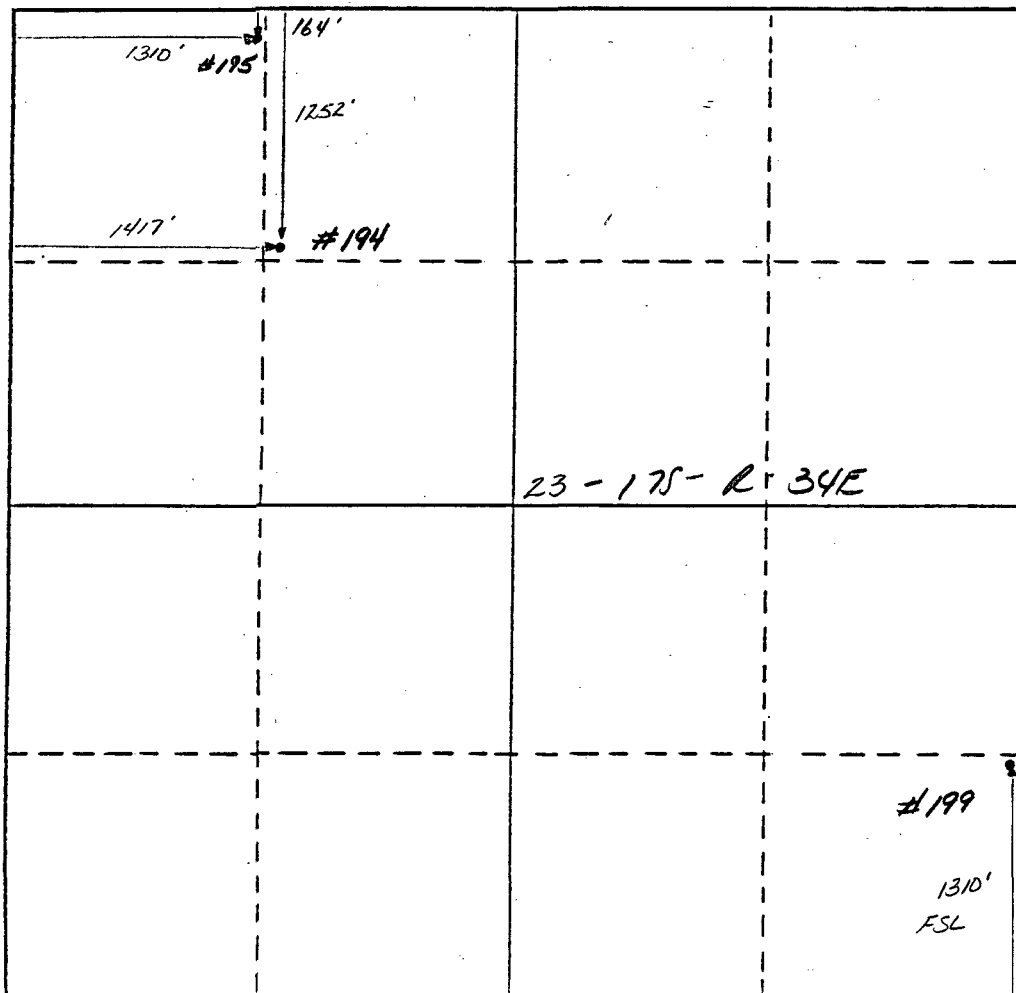
