

Dear Mr. Stamets:

This is a request for administrative approval for an unorthodox gas well location in the Aztec Fruitland Ext Pool.

It is intended to locate the El Paso Natural Gas Company's Hubbell #20 at 2160' from the South line and 870' from the West line of Section 17, T-29-N, R-10-W, San Juan County, New Mexico.

Extremely rough terrain with cliffs and ledges, an existing pipeline and another gas well location in the southwest corner of this section makes it impossible to build an orthodox gas well location.

A copy of this application is being submitted to all offset operators by certified mail with a request that they furnish your Santa Fe office with a Waiver of Objection, and return one copy to this office.

Plats showing the proposed well location and the terrain in Section 17, along with an ownership plat, are attached.




