Lightening strike to oil storage tank which exerted sufficient pressure to produce a hole in the bottom from which the oil leaked out. Tank had approximately 6' in it prior to strike - 5" to 6" remained after flow.

Tank battery area and minimally onto ranch property. Backhoe was secured to remove contaminated soil, placing it onto a plastic tarp for future removal.
