

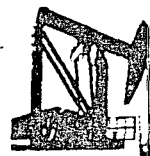

Gentlemen:

Reference is made to your application for two non-standard locations for the following wells in the Langlie Mattix Pool in Lea County, New Mexico, as follows:

Langlie-Jal Unit #109 Well to be located 2555' FNL and 120' FEL of Section 5, T-25-S, R-37-E; the SE/4 NE/4 of said Sec. 5 to be dedicated to the well; and

Langlie-Jal Unit #111 Well to be located 2600' FEL and 50' FSL of Section 5, T-25-S, R-37-E; the SW/4 SE/4 of said Sec. 5 to be dedicated to the well.
