



Amoco Production Company hereby requests approval of an unorthodox well location for the Gallegos Canyon Unit No. 137E. The proposed location is 1110' FSL x 940' FWL of Section 36, T28N, R13W, San Juan County, New Mexico.

This well was staked in the location indicated above in order to place the well in an orthodox window for the Basin Dakota Formation. After the permit to drill was approved, it was decided to dual complete the well in the Cha Cha Gallup Formation as well.

There are no offset lease holders of Cha Cha Gallup Extension wells as indicated on the attached nine-section plat.






