

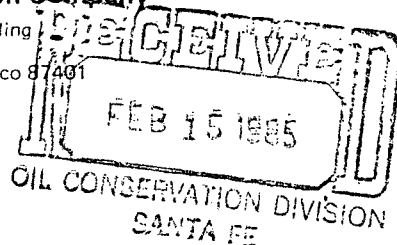

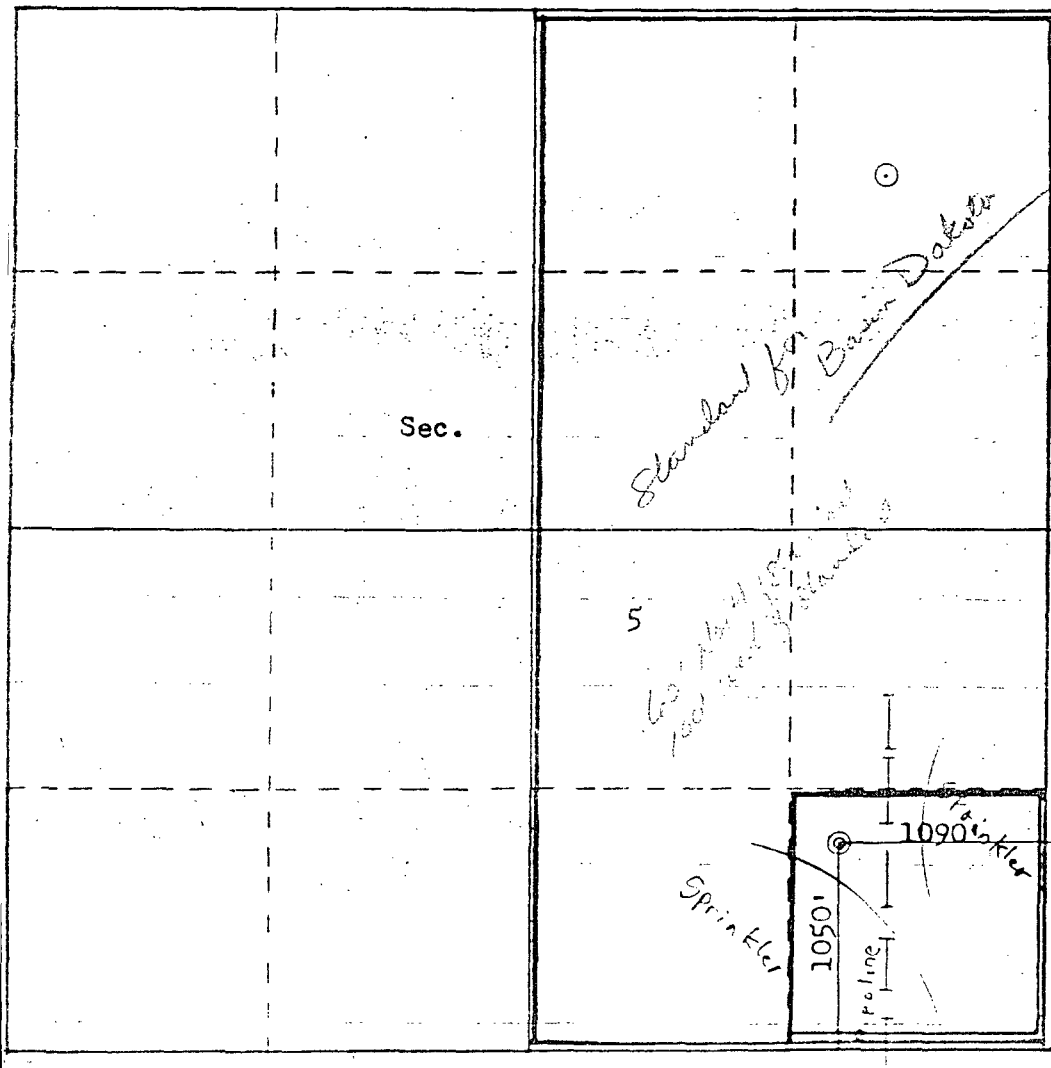

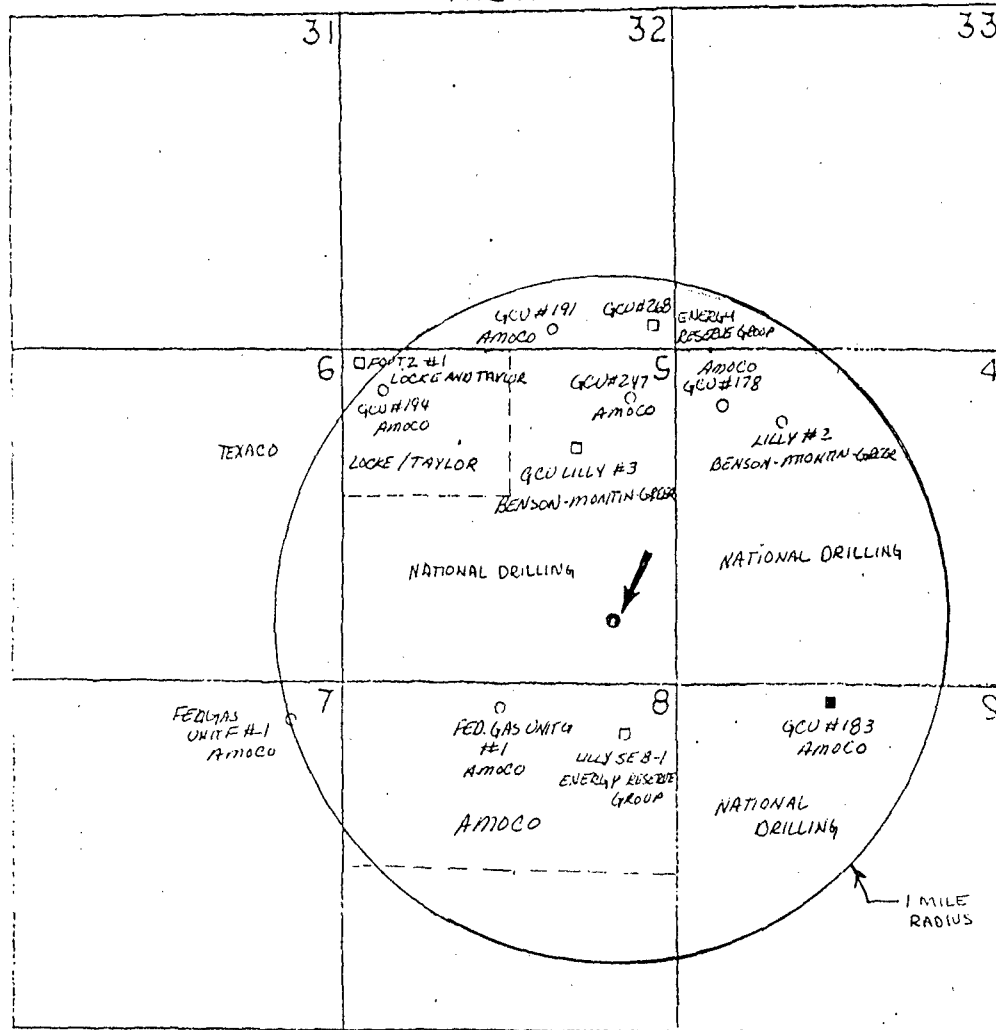

- PROPOSED WELL

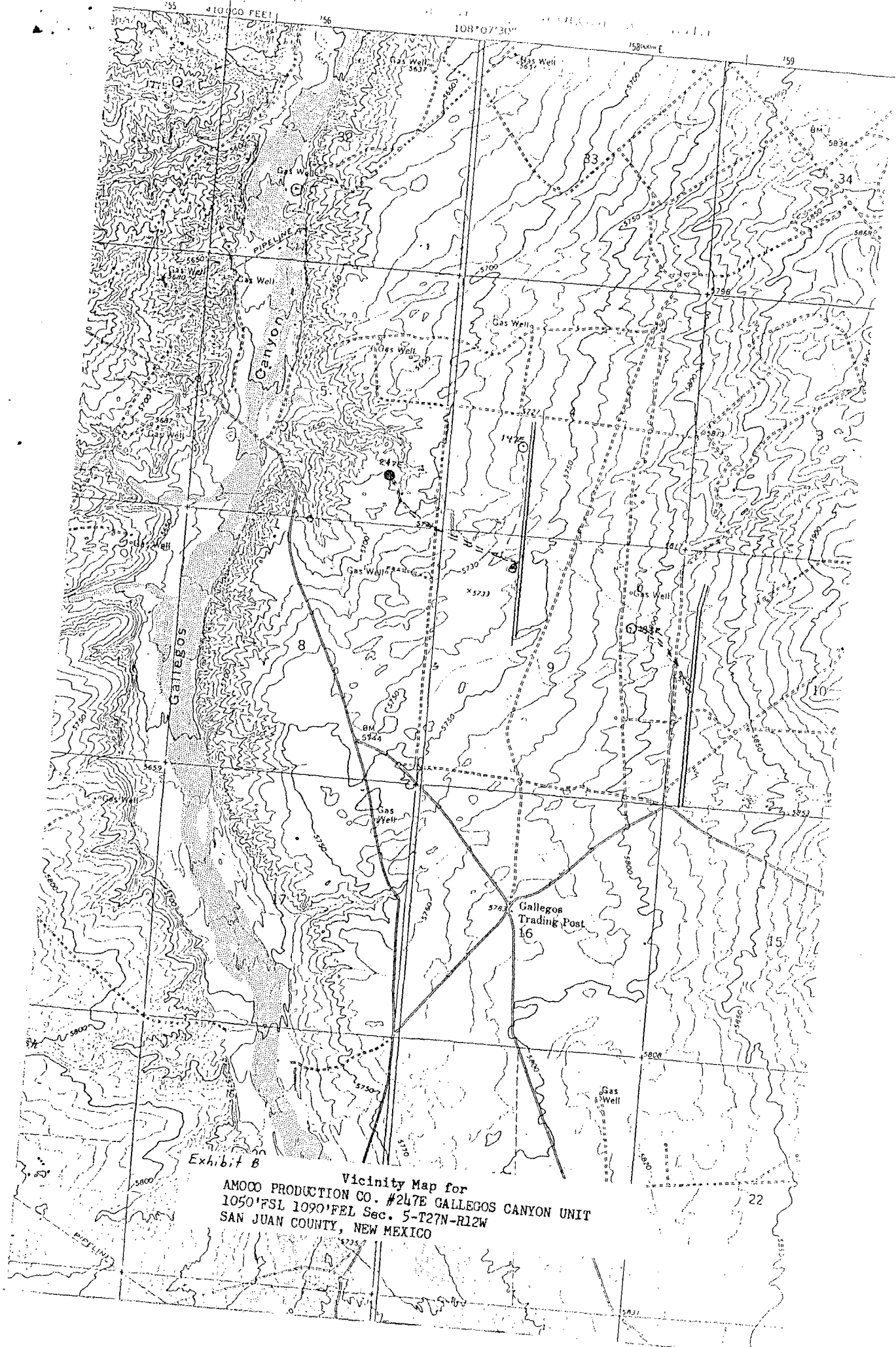

SAN JUAN COUNTY, NEW MEXICO



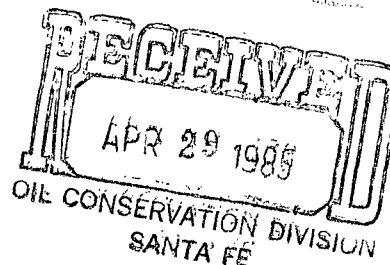

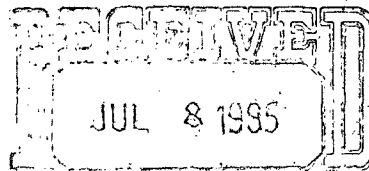
