

Dear Mr. Stamets:

The purpose of this letter is to request administrative approval without notice and hearing of unorthodox well locations pursuant to Order R-7808 of the New Mexico Oil Conservation Division. The following is a list of the footage locations for which administrative approval of unorthodox well locations are sought:

G. J. WEST CO-OP UNIT NO. 76
330 FSL 1090 FEL
Section 28, T-17S, R-29E
Eddy County, New Mexico

The well will be completed in the Grayburg San Andres formation in the Grayburg Jackson Seven Rivers Queen Grayburg San Andres Pool. Note that these locations are no closer than 330 feet to an outer boundary of a lease, or in the case of a unit, unitized area, nor closer than 10 feet to any quarter quarter section line or subdivision inner boundary.

Attached to this application as Exhibits A through C are the following:

- A. Well location and Acreage Dedication Plat (Forms C-102) filed with the Artesia office of the Oil Conservation Division (Exhibit "A").

- B. A plat showing the proposed unorthodox locations, the respective proration units, and the offsetting proration units including ownership of the offsetting proration units in the Grayburg San Andres formation in the Grayburg Jackson Seven Rivers Queen Grayburg San Andres Pool (Exhibit "B").

- C. Copies of the letters of notification sent to operators or owners of proration units offsetting proration units containing the proposed unorthodox locations in the Grayburg Jackson Seven Rivers Queen Grayburg San Andres Pool (Exhibit "C").

The letters attached as Exhibit "C" have been sent to the offset operator by certified mail and they have been requested to notify you if they have any objection. Note that with the exception of the operators notified Marbob Energy Corporation is the operator of all offsetting proration units in the Grayburg San Andres formation of the Grayburg Jackson Seven Rivers Queen Grayburg San Andres Pool.
