Describe Cause of Problem and Remedial Action Taken.*

A lightning strike caused the fiberglass tank battery facility to ignite and burn to the ground. We are in the process of investigating possible grounding solutions for these facilities, including copper wire grounding into the freshwater aquifer.

Describe Area Affected and Cleanup Action Taken.*

The entire facility was cleaned, removed, and taken to an OCD approved land farm for remediation. The affected soil was removed and taken to the same facility. Fresh caliche and topsoil was hauled in and spread over the area. The tank battery was reconstructed and set on a 20 ml polyethylene liner. Earthen burms were built around the tank battery and covered with the liner.




