I would like to make application for an unorthodox location as set out above. In that connection, I am enclosing the following in triplicate:

1. A land plat showing the ownership of all direct and diagonal off-setting locations.
2. NMOCC Form C-102
3. Structure map dated 10/22/85 prepared on my behalf by geologist, Edsel B. Neff.
4. Isopach map dated 1/2/87 prepared on my behalf by geologist, Edsel B. Neff.
5. Letter dated September 29, 1987 wherein Yates Petroleum Corporation waives any objection to unorthodox location. Yates Petroleum Corporation is the operator of all direct and diagonal off-setting locations to this unorthodox location.
6. My letter dated September 23, 1987 directed to Meridian Oil Production, Mobil Producing and Bassett Birney Oil Corporation. These are the only off-setting owners of leases except Yates Petroleum Corporation and Robert N. Enfield et al.
7. Return Receipts signed by the above three addressees, indicating that they did receive said letter.

As you will note by the structure map, the standard location would be very close to the gas/water contact. Therefore in order to secure a better structural and stratigraphic position, I am requesting that this unorthodox location be granted.

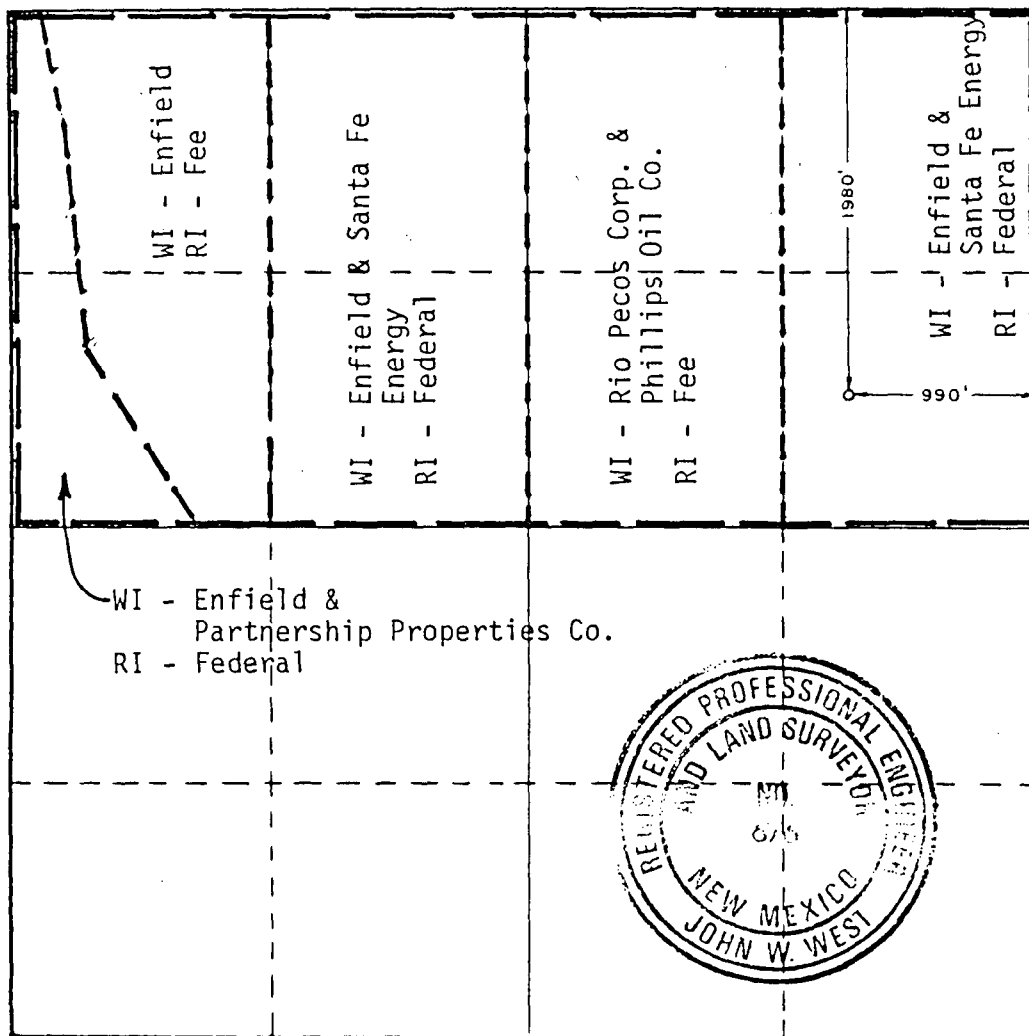

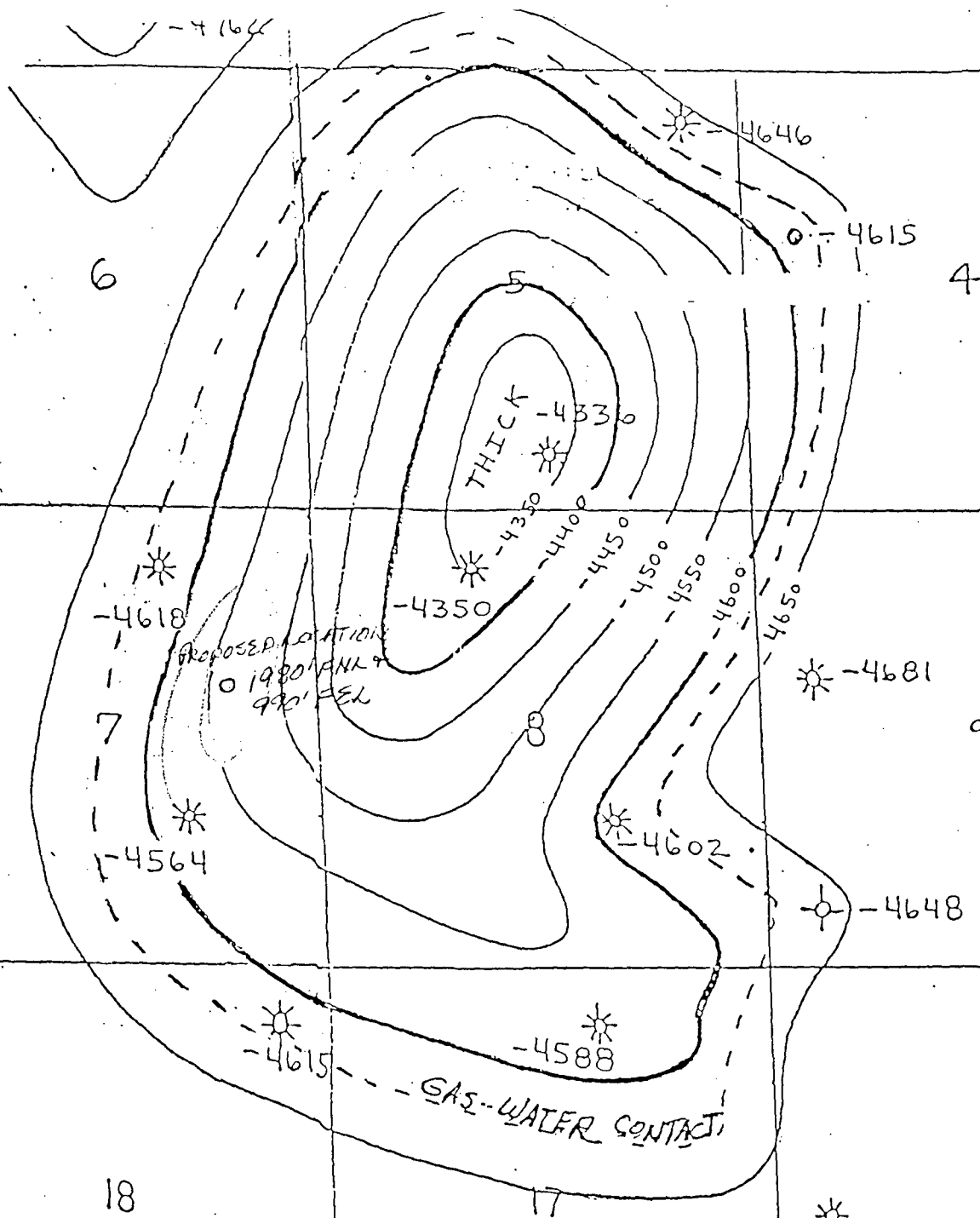

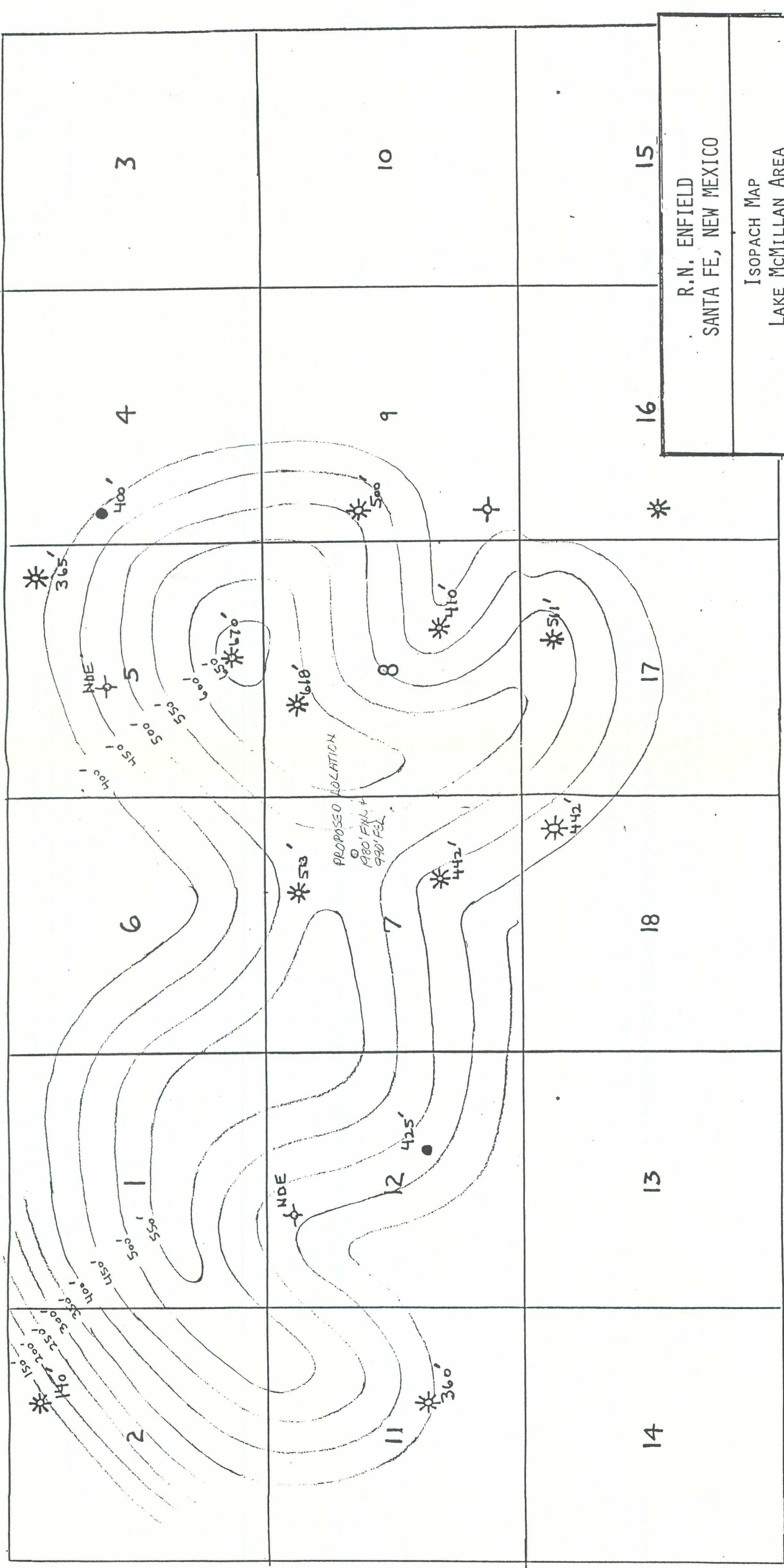
