Dear Mr. Le May:

T. H. McElvain Oil & Gas Properties, hereinafter referred to as "McElvain", as operator of State of New Mexico Oil & Gas Lease No. E-9055-15 dated December 23, 1962, hereby requests administrative approval of an unorthodox location for the drilling of our Thirlaway #1 at a location 1585' FNL and 1925' FEL of Section 36, T-24N, R-7W, NMPM, Rio Arriba County, New Mexico. The proration unit to be dedicated to this well is the S/2NE/4 of Section 36. The proposed unorthodox location lies 75' west and 65' north of a legal location under the Escrito Gallup Associated Pool Rules (See attached plat labeled Exhibit A).

This shift of the location slightly to the northwest of a legal location is necessary due to a large arroyo running East-West through the spacing unit (See attached topo sheet labeled Exhibit B). If it becomes necessary for us to shift our location further south and east, we will have to build a road across this large arroyo and cut the location into the hillside on the south side of the arroyo. This would give us a large added expense plus limiting our access to the well location during heavy rains and snowy conditions.

In compliance with Rule 2(c) of the General Rules & Regulations - Associated Oil & Gas Pools, McElvain submits herewith on the attached plat labeled Exhibit A, the ownership of all leases offsetting the proration unit and all wells completed thereon. We are also including as Exhibit C the names and addresses of all the offset owners which McElvain has served notice upon of this application by certified mail. We have requested waivers from each of these owners.

It is the opinion of McElvain that approval of this application will prevent waste and protect correlative rights.

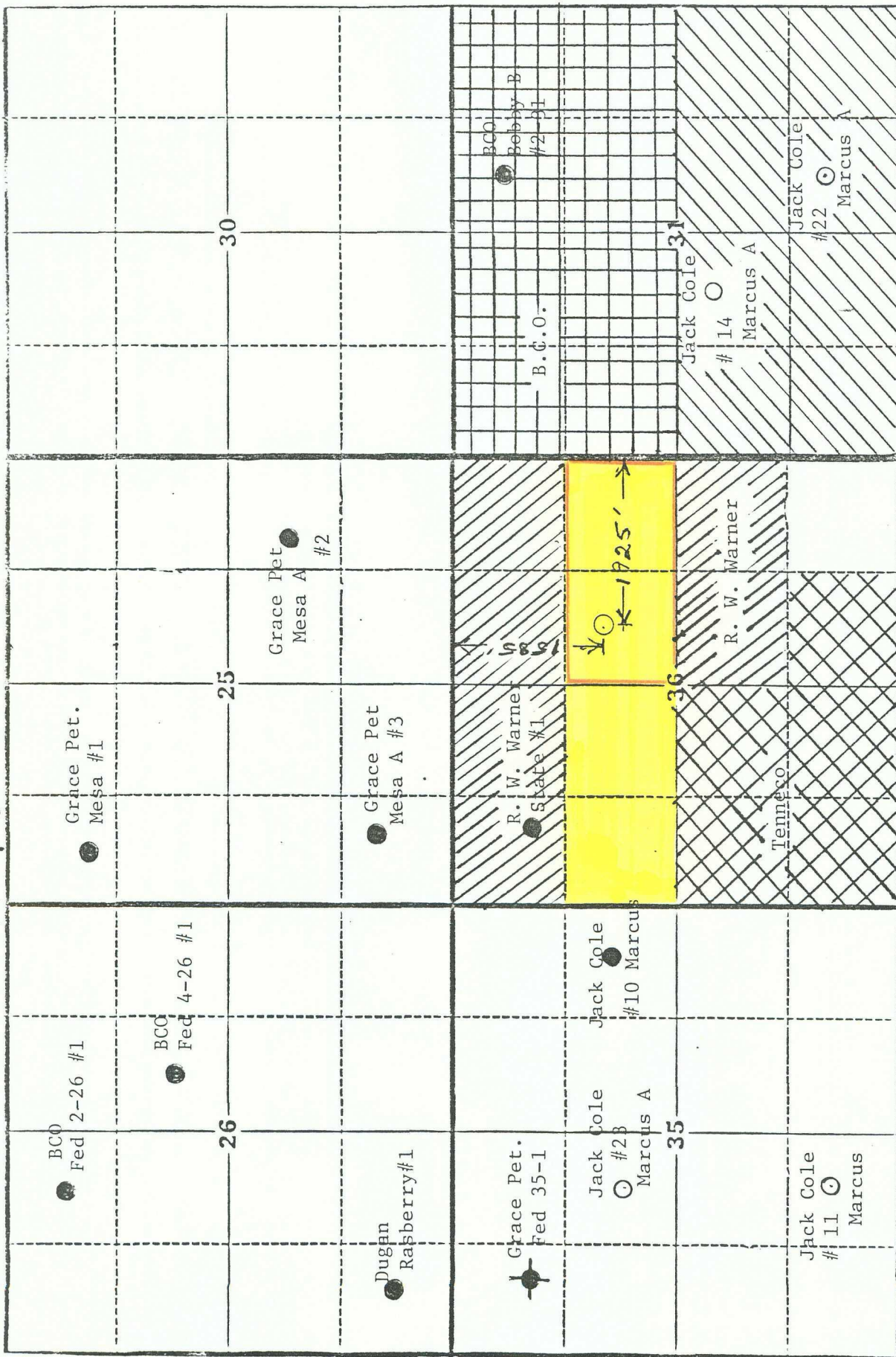

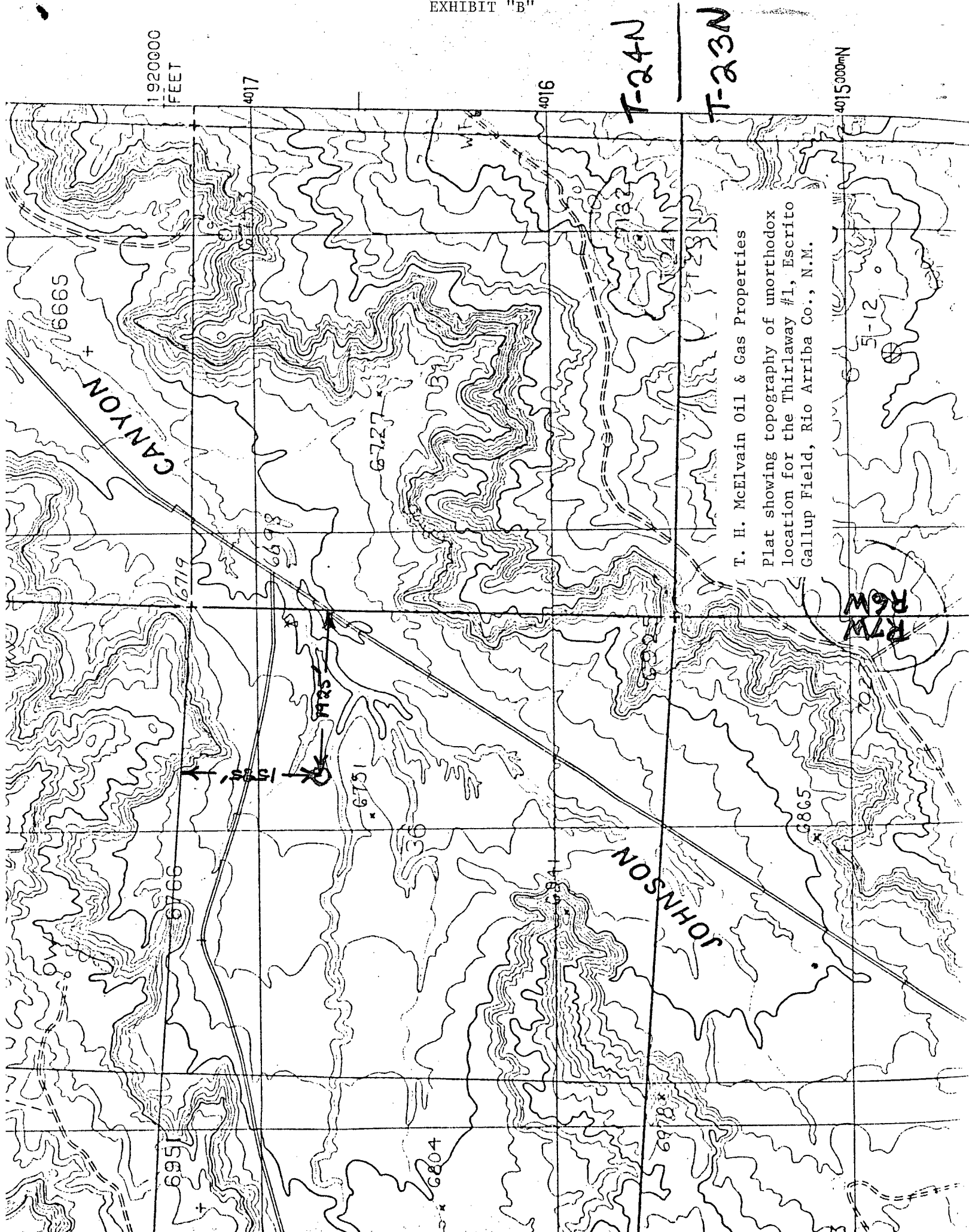
