Dear Ms. Whitley:

Reference is made to your application for non-standard locations for the following wells:

West Dollarhide Queen Sand Unit No. 98 to be located 2610 feet from the South line and 115 feet from the East line of Section 31, the NE/4 SE/4 of said Section 31 shall be dedicated to the well;

West Dollarhide Queen Sand Unit No. 99 to be located 1130 feet from the South line and 2110 feet from the East line of Section 31, the SW/4 SE/4 of said Section 31 shall be dedicated to the well;

West Dollarhide Queen Sand Unit No. 100 to be located 240 feet from the North line and 1660 feet from the East line of Section 30, the NW/4 NE/4 of said Section 30 shall be dedicated to the well;

West Dollarhide Queen Sand Unit No. 101 to be located 1090 feet from the South line and 1610 feet from the West line of Section 30, the SE/4 SW/4 of said Section 30 shall be dedicated to the well;

West Dollarhide Queen Sand Unit No. 102 to be located 1530 feet from the North line and 2600 feet from the East line of Section 30, the SW/4 NE/4 of said Section 30 shall be dedicated to the well;

West Dollarhide Queen Sand Unit No. 103 to be located 1560 feet from the North line and 1610 feet from the West line of Section 30, the SE/4 NW/4 of said Section 30 shall be dedicated to the well;

West Dollarhide Queen Sand Unit No. 105 to be located 2380 feet from the South line and 1570 feet from the West line of Section 30, the NE/4 SW/4 of said Section 30 shall be dedicated to the well;


West Dollarhide Queen Sand Unit No. 106 to be located 90 feet from the North line and 1470 feet from the West line of Section 30, the NE/4 NW/4 of said Section 30 shall be dedicated to the well;

West Dollarhide Queen Sand Unit No. 107 to be located 230 feet from the North line and 2630 feet from the East line of Section 30, the NW/4 NE/4 of said Section 30 shall be dedicated to the well;

All locations are in Township 24 South, Range 38 East, NMPM, Dollarhide Queen Pool, Lea County, New Mexico.

By authority granted me under the provisions of Rule 104 F(I), the above-described unorthodox locations are hereby approved.
