Request for Unorthodox Location - MCA Unit No. 381, 2515' FSL & 1720' FWL, Section 30, T-17S, R-33E, Lea County, NM. Maljamar Grayburg/San Andres

Conoco Inc. respectfully requests administrative approval to drill the subject well at an unorthodox location in unit letter K, 2515' FSL & 1720' FWL, Section 30, T17S, R33E, Lea County, New Mexico. This well will be drilled on 20-acre spacing as provided for in Order No. 2403, dated December 31, 1962.

The drilling of the MCA Unit No. 381 at a non-standard location is necessary to permit the completion of an efficient production and injection pattern within a pressure maintenance project.





