
Reference is made to your application dated January 19, 1994, for a non-standard Atoka gas well location for your existing Federal "N" Well No. 1 (API No. 30-015-25965), which was drilled in 1988 to a depth of 11,500 feet in the Morrow formation at a previously approved non-standard gas well location (Division Administrative Order NSL-2560, dated August 22, 1988) 467 feet from the South line and 660 feet from the West line (Unit M) of Section 6, Township 22 South, Range 26 East, NMPM, Eddy County, New Mexico.

It is my understanding that said well will be recompleted to the Atoka formation, which pursuant to Division General Rule 104.C(2)(b), is also unorthodox. Further, Lots 3 through 7, the SE/4 NW/4 and the E/2 SW/4 (W/2 equivalent) of said Section 6 shall be dedicated to the well forming a 317.91-acre gas spacing and proration unit.

By the authority granted me under the provisions of Division General Rule 104.F(1), the above-described unorthodox gas well location is hereby approved.

Said Original Order NSL-2560 shall be placed in abeyance until further notice.
