

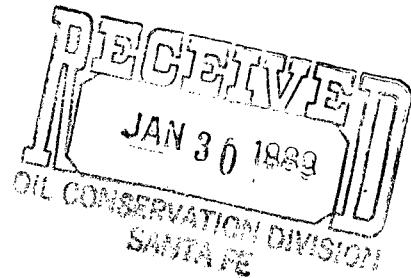

Dear Mr. LeMay;

Blackwood & Nichols Co., Ltd. requests administrative approval of an exception to the location requirements of Rule 7, R-8768 for the subject well, located in the Basin Fruitland Coal Pool.

This request is for exception due to topography. A Vicinity Map and C-102 are attached for your reference. As evidenced by the Vicinity Map, all of the standard footage window in the Northeast quarter is covered by Navajo Reservoir. This standard location in the Northwest quarter was staked as the best alternative. A non standard footage location by the NEBU # 44 (NE-4-30-7) was not considered acceptable due to it's proximity to the shoreline.

The west half of Section 30 will be dedicated to this well. All offset proration units are operated by Blackwood and Nichols Co., Ltd.

Your prompt consideration of this request is appreciated.

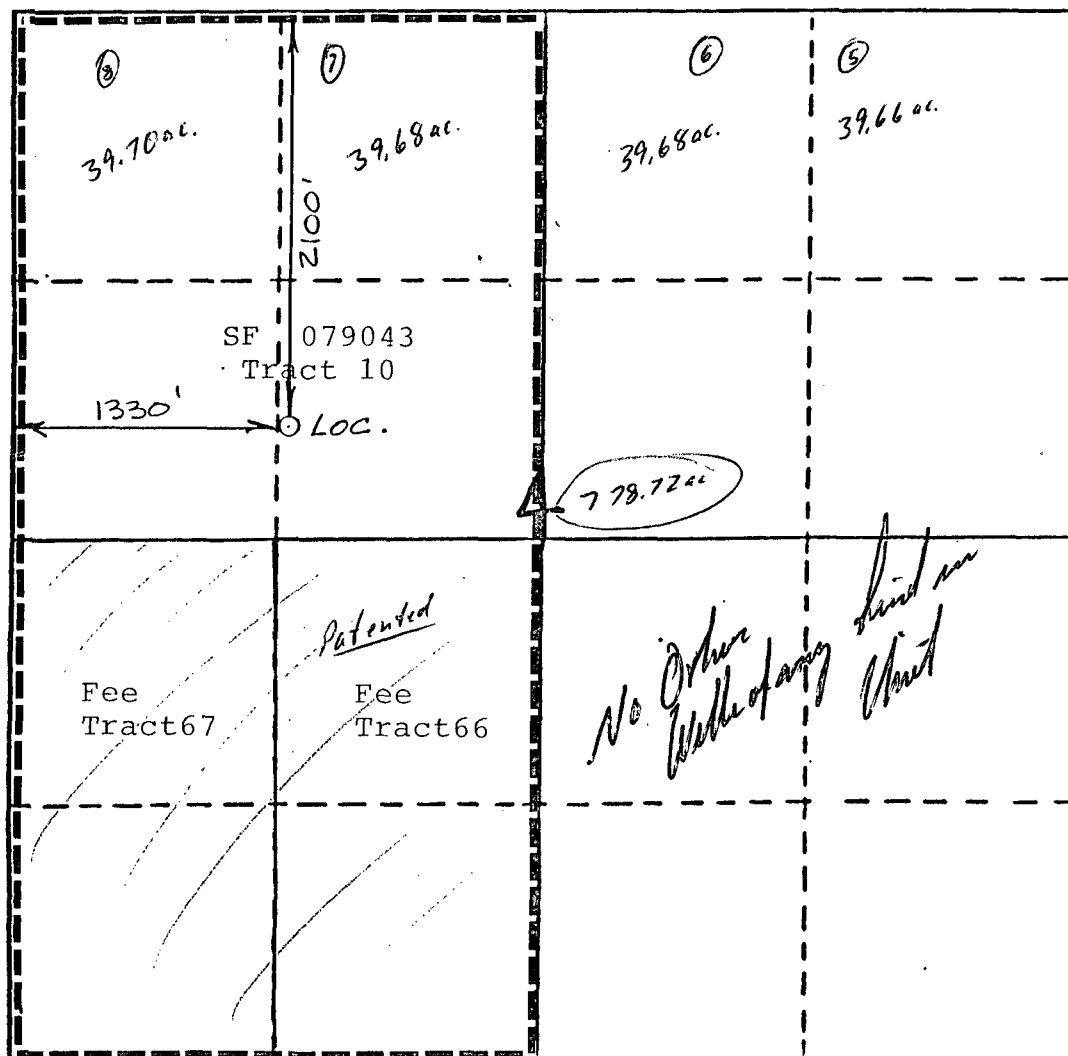

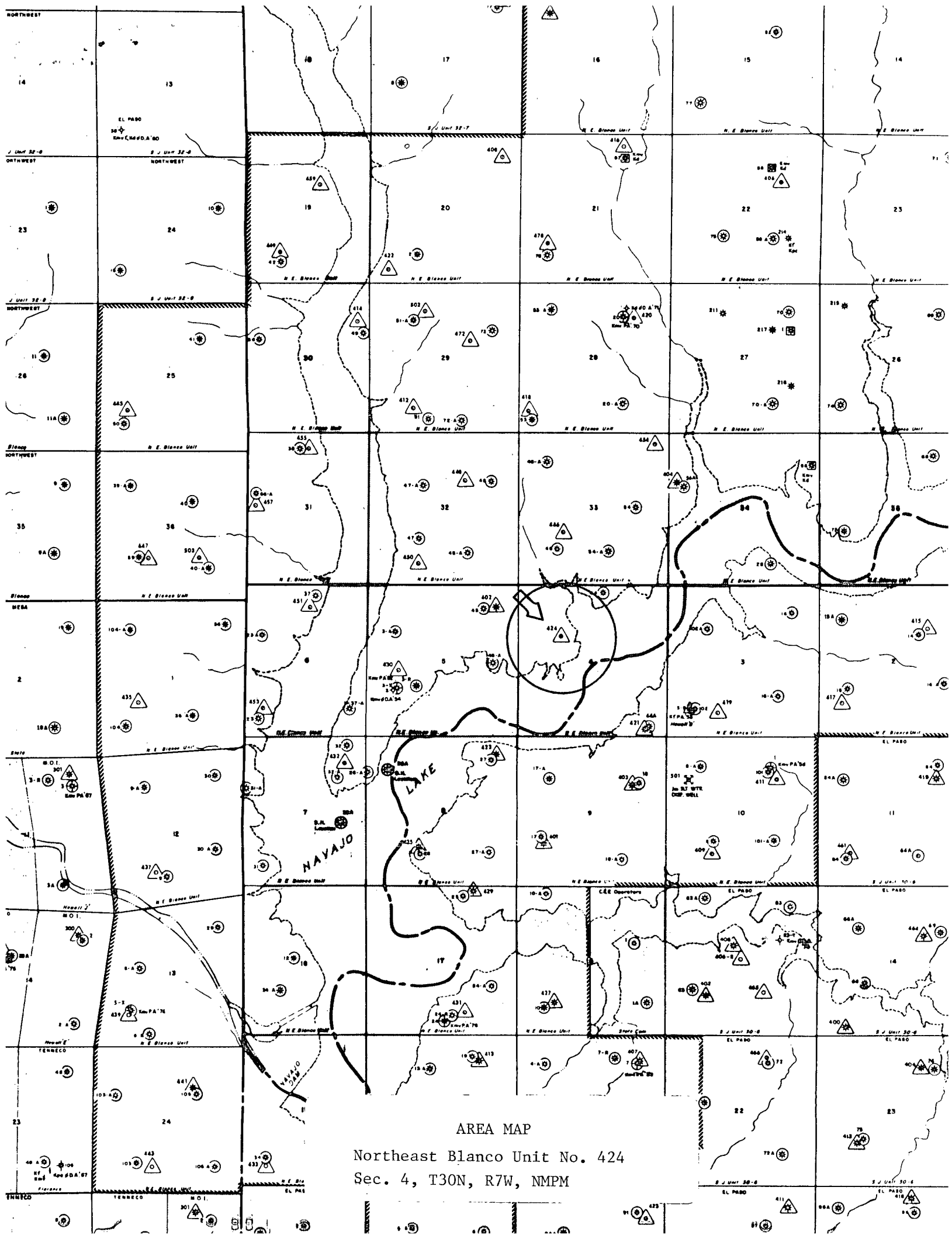

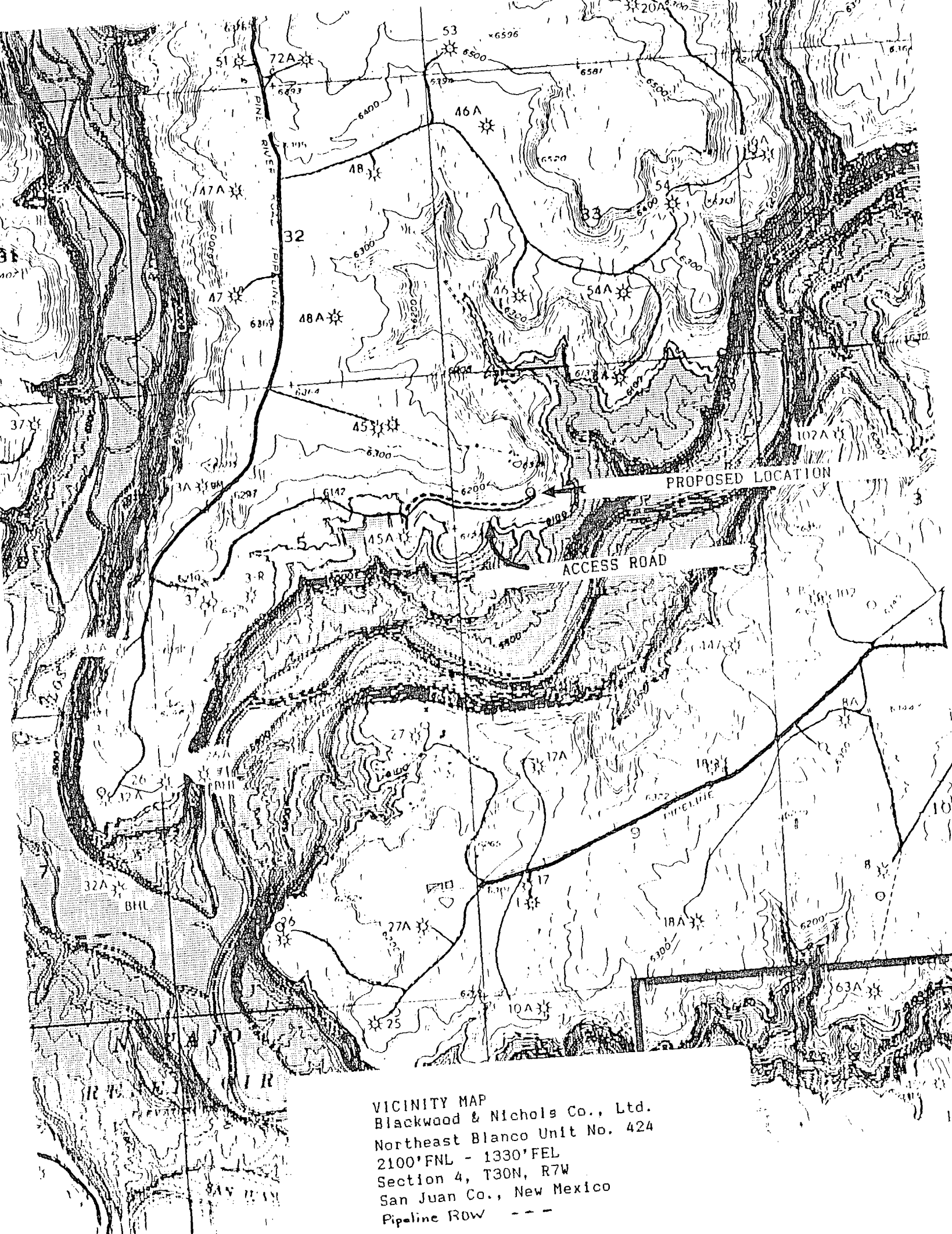
