Reference is made to your application of August 23, 1989 for a nonstandard oil well location for your Lybrook "19" Well No. 2R to be located 2157 feet from the South line and 2004 feet from the West line (Unit K) of Section 19, Township 24 North, Range 6 West, NMPM, Devils Fork Gallup Associated Pool, Rio Arriba County, New Mexico. The SW/4 of said Section 19 shall be dedicated to the well forming a standard 160-acre oil spacing and proration unit for said pool.
