Dear Mr. Basham:

Reference is made to your application dated March 7, 1990 for 12 unorthodox Dollarhide Tubb-Drinkard Pool oil well locations all within the West Dollarhide Drinkard Unit Waterflood Project Area, Lea County, New Mexico. Said locations would permit the completion of an efficient production/injection pattern within the existing secondary recovery project. Further, each well is location well within the boundary of said project area, thereby no offset operators will be affected. With the exception of one location (Well No. 97), the other eleven met all of the requirements for administrative approval pursuant to General Rule 104.F. at this time.

THEREFORE, by the authority granted me under the provisions of General Rule 104 F(I) the following unorthodox Dollarhide Tubb-Drinkard Pool oil well locations are hereby approved:



Dear Mr. Basham:

I am unable to administratively approve the subject well location at this time. Division General Rule 104.F.I. requires that a well within a secondary recovery project be at least 10 feet from any interior quarter-quarter section line; the No. 97 well is only two feet from the NE/4 SE/4 and NW/4 SE/4 section line.

If possible, could this location be moved to satisfy the requirements? If not, this location will unfortunately require a hearing before authorization by this Division can be made.'

I will hold this one well from any action the Division takes on this matter until I hear from you.

Amended Administrative Order NSL-2768

Dear Mr. Basham:

Reference is made to your letter dated September 18, 1990 requesting to amend the location of the West Dollarhide Drinkard Unit Well No. 100 which was approved by Division Administrative Order NSL-2768 to be 1169 feet from the South line and 70 feet from the West line (Unit M) of Section 29, Township 24 South, Range 38 East, NMPM, West Dollarhide Drinkard Unit Waterflood Project Area, Dollarhide Tubb-Drinkard Pool, Lea County, New Mexico.

It is our understanding that said amendment is necessitated in order to avoid an overhead electric line. Therefore, by authority granted me under the provisions of General Rule 104.F.I., said Order is hereby amended to reflect the location of the No. 100 well as 1169 feet from the South line and 120 feet from the West line (Unit M) of said Section 29.

All other provisions of said Order NSL-2768 shall remain in full force and effect until further notice.
