Please accept our apologies for sending you a very poor quality topographical map with our unorthodox request. The enclosed supplemental map and project area description from the NEBU #468 Archeological Report, has the proposed location spotted and the well pad and construction zone outline to the correct scale. I have also located the Northwest Pipeline's 30" main gas line and the NEBU #68 Mesa Verde well. The supplemental map more clearly supports the original proposed location after taking into account all topographical and manmade features the original map failed to explain.


Based on the topographical map and our field surveys, the area south and east of the #68 is too small to allow for an open hole, completion type, coalbed methane well to be drilled in a safe manner.

The NEBU #468 proration unit is bordered on all four sides by Blackwood & Nichols. The only offset proration unit is located adjacent to the southeast corner. Meridian has operated the west half of section 1, T30N, R7W, under a designation of agent with Northwest Pipeline and was mistakenly sent a Waiver of Objection Request. Northwest Pipeline is currently in the process of transferring operatorship to Phillips Petroleum Company. Both Northwest Pipeline and Phillips have been sent a Waiver Proposal. As per your request, a Northeast Blanco Unit map with offsetting operators is also enclosed.

Environment: The project area is on a finger of Burnt Mesa on the east side of Negro Andy Canyon overlooking Navajo Reservoir to the south. The area to the east is an east-facing slope which is steep and heavily cobbled the entire way down to the reservoir. The area immediately north of the existing pad (NEBU 68) and south of the center stake, is a pinyon and juniper woodland with sandy soil. The 10 to 15% cover consists of pinyon and juniper, sagebrush, grasses, forbs, snakeweed, prickly pear cactus and narrow leaf yucca. There are also sandstone outcrops ranging in size from pebbles to boulders. Two whole, but cracked petrified logs are present, as are numerous "chunks" of petrified wood on the west side of the location. North of the center stake is a chained area with a 35% cover of sagebrush, grasses, forbs and prickly pear cactus.

Project Description: The project consists of a gas well near existing well pad NEBU 68. An existing pipeline parallels the west side of the proposed well.

Cultural Resources: No sites or isolated locus were found during the survey.

Recommendations: Archaeological clearance is recommended.
