Dear Mr. Grafe:

Reference is made to your application dated October 13, 1992 for two unorthodox Jalmat gas well locations in an existing non-standard 640-acre gas spacing and proration unit (GPU) for said Jalmat Gas Pool comprising the N/2 and SW/4 of Section 13 and the NE/4 of Section 14, both in Township 23 South, Range 36 East, NMPM, Lea County, New Mexico. Said GPU was authorized by Division Order No. R-9073, dated December 14, 1989 (Paragraph No. (11) of Exhibit "A") and had decided thereon the State "A" A/C-1 Well Nos. 20, 21, and 22 located, respectively, in Units C, H, and N of said Section 13 and Well Nos. 77 and 13 located respectively in Units B and H of said Section 14 to this proration unit.

By Division Order R-9073-A, dated February 28, 1990, three additional wells, the State "A" A/C-1 Well Nos. 66, 71, and 75, located at unorthodox gas well locations in Units D, M, and L, respectively, of said Section 13 were approved for the subject GPU.

Further, by Division Administrative Orders NSL-2874 and NSL-2874-A, dated September 25, 1990 and January 18, 1991, respectively, three more wells, the State "A" A/C-1 Well Nos. 57, 106, and 122, located at unorthodox gas well locations in Units B, A, and L, respectively, of said Section 13 were approved for the subject GPU. Authorization was also given in said administrative order to simultaneously dedicate Jalmat Gas production from the State "A" A/C-1 Well Nos. 13, 20, 21, 22, 57, 66, 71, 75, 77, 106 and 122 to the subject GPU.

It is our understanding that the two subject wells to be considered at this time are currently completed in the Langlie-Matrix Pool, however, said wells will be plugged back to the Jalmat Gas Pool upon issuance of this order.

By authority granted me under the provisions of Rule 2(c) of the Special Rules and Regulations for the Jalmat Gas Pool, as promulgated by Division Order No. R-8170, as amended, the following two described wells located at unorthodox gas well locations are hereby approved:



Also, you are hereby authorized to simultaneously dedicate Jalmat Gas production from the State "A" A/C-1 Well Nos. 60 and 78 with the State "A" A/C-1 Well Nos. 13, 20, 21, 22, 57, 66, 71, 75, 77, 106, and 122; furthermore, you are hereby permitted to produce the allowable assigned the GPU from all of the said wells in any proportion.

All provisions of Division Order R-9073-A, dated February 28, 1990, Division Administrative Order NSL-2874, dated September 25, 1990, Division Administrative Order NSL-2874-A, dated January 28, 1991, and those provisions applicable to the subject GPU in Division Order No. R-9073 shall remain in full force and effect until further notice.

Gentlemen:

Clayton W. Williams, Jr., Inc. respectfully requests your approval of this administrative application for the subject Unorthodox Gas Well Locations and Simultaneous Dedication.

Clayton W. Williams, Jr., Inc. is planning to re-complete it's State "A" A/C 1 Well Nos. 60 and 78 in the Jalmat Tansil Yates 7-Rivers (Pro Gas) Pool. It is our desire to also simultaneously dedicate the existing 640-acre Jalmat Gas Proration Unit assigned to our State "A" A/C 1 Well Nos. 77, 13, 66, 122, 71, 20, 75, 22, 57, and 106 to all twelve wells. As a result, the location of the State "A" A/C 1 Well Nos. 60 and 78 become unorthodox in that they are less than 990 feet from the outer boundary of the proration unit. The location of Well No. 60 is 1980 feet FNL and 1980' FEL of Section 13, T-23-S, R-36-E, Lea County, New Mexico. The location of Well No. 78 is 1980 feet FNL and 1980' FEL of Section 14, T-23-S, R-36-E, Lea County, New Mexico.

In order to prevent waste, Clayton W. Williams, Jr., Inc. respectfully requests your approval of this administrative application for unorthodox gas well locations and simultaneous dedication. Attached is a map showing offset operators and a Form C-102 plat for each well. 
