Gentlemen:

Texaco respectfully requests permission to recomplete the subject well at an unorthodox location in the Fulcher Kutz PC Pool. The subject well was plugged back after developing a casing leak and a replacement well was drilled nearby. The well has remained shut in since that time. Texaco plans to test uphole potential in the Pictured Cliffs and will plug the well if no commercial production is found. This location will not affect offset operators since it maintains the required footage buffers from the section lines and Texaco owns the PC rights in the remainder of the section.

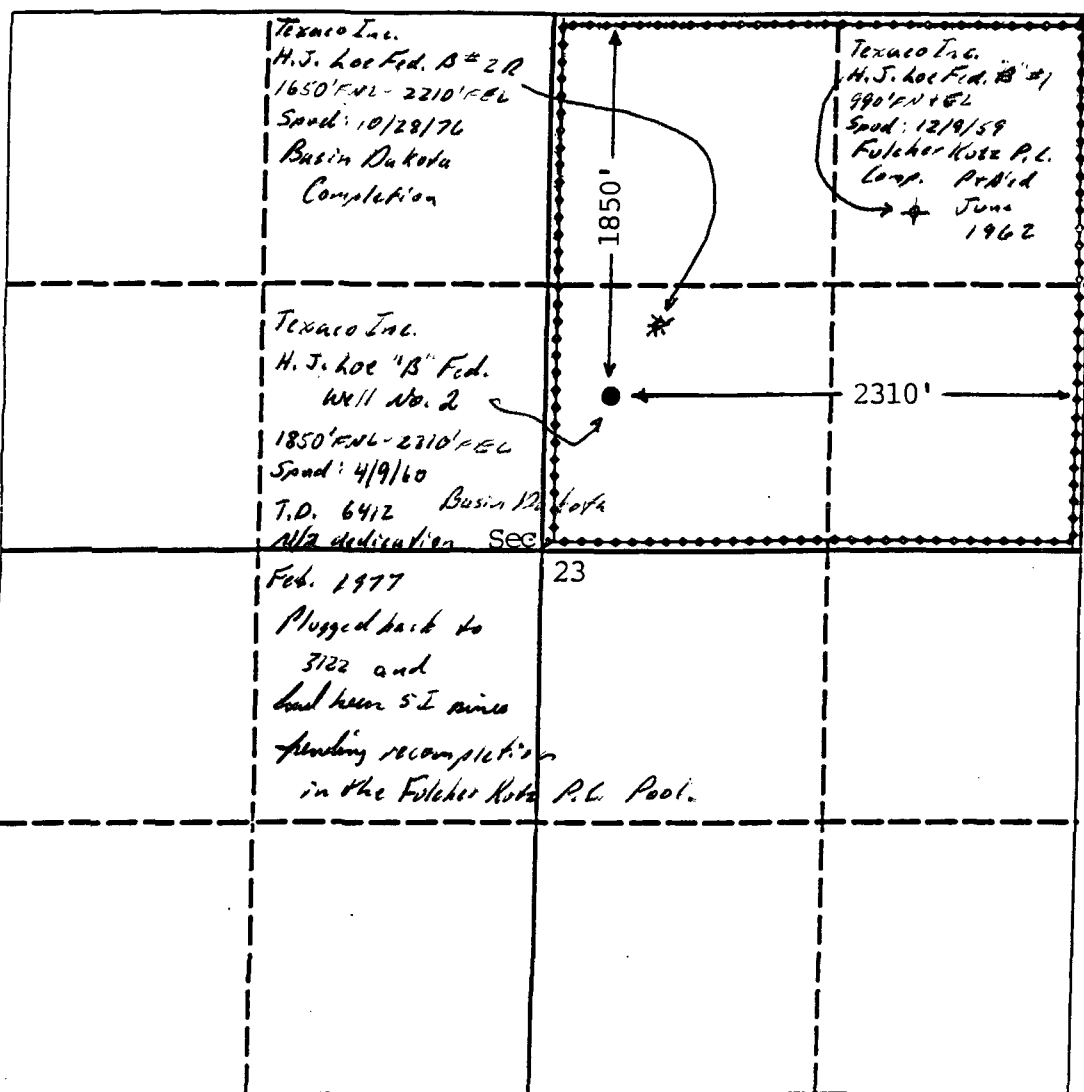
