Gentlemen:

Texaco Inc. respectfully requests permission to complete the above referenced well at an unorthodox location in the South Blanco (Picture Cliffs) Pool. The Jicarilla "B" Well No. 12 was drilled to a TD of 6220' in August of 1958 with 5-1/2" casing set at 6210' and was completed in the Gallup formation. Texaco now proposes to plug the Gallup perforations and recomplete the well in the Picture Cliffs formation.

At the present time, Jicarilla "B" Well No. 13 which is located in the same quarter section as the referenced well, is currently completed in the Picture Cliffs. Prior to commencing any operations to recomplete Well No. 12, Texaco will plug and abandon the Picture Cliffs formation in Well No. 13.


