Gentlemen: 47 ;

We are in receipt of your letter of September 10, 1990 (received September 12, 1990) wherein Chevron has given notice of its proposed reentry of Pan American's (AMOCO) Gillully "B" Federal No. 14 and of its proposed completion of the well to a Eumont Yates 7 Rivers Queen (Pro Gas) Pool well. We are also on notice of Chevron's request for approval of an unorthodox location for the Gillully "B" Federal No. 14 (Bell Ramsay (NCT-C) Com No. 2) and to simultaneously dedicate the well along with the existing Bell Ramsay (NCT-C) Com No. 1 (J-34-20S-37E) to the existing 480-acre Eumont Gas Proration Unit consisting of the S/2 & NW/4 Section 34, T-20-S, R-37-E, Lea County, New Mexico.

As on offset operator, Doyle Hartman must at this time conditionally object to Chevron's waiver request concerning the above proposal.

In addition to the above referenced waiver request and our denial of such, it appears that over the past several months that Chevron and Doyle Hartman have been on opposing sides concerning the redevelopment of certain acreage located in the Eumont and Jalmat Gas Pools. Specifically the following comes to mind:

1) Chevron's opposition to Doyle Hartman's proposed 280-acre Britt-Laughlin Eumont proration unit (NMOCD Case # 9898) wherein Hartman (in order to accommodate Chevron's objection) voluntarily consented to limiting the producing rate of his Britt-Laughlin Com No. 5 well in Chevron USA, Inc. September 28, 1990 Page 2

order to be able to receive a timely order from the NMOCD (Order No. R-9199).

2) Chevron's opposition to Doyle Hartman's proposed 280-acre State "A" communitized proration unit (NMOCD pending Case # 9994) wherein Hartman proposed the pooling and drilling of the infill State "A" Com No. 5 well after various attempts had been made by Hartman to purchase, trade, farm-in, or include Chevron's acreage so that the proposed proration unit and acreage could be fully and efficiently developed.

3) Doyle Hartman's conditional opposition to Chevron's proposed 400-acre Graham St. NCT-E proration unit and unorthodox gas well location (NMOCD pending Case No. 9949) wherein Hartman opposed Chevron's application unless Chevron approved Hartman's similar proposal as to the adjacent State "A" Com acreage.

4) Doyle Hartman's conditional opposition to Chevron's proposed 240-acre Meyer-Bell Ramsay proration unit and the subsequent reconfiguration of the two (2) 120-acre Bell Ramsay "A" No. 5 and No. 8 proration units (NMOCD pending Case # 10092) wherein Hartman opposed Chevron's application being approved without Chevron's approval of Hartman's similar proposal as to the adjacent State "A" Com acreage.

5) Chevron's current opposition and non-cooperation with Doyle Hartman's proposed 198-acre Carter Eaves proration unit and associated infill gas well proposal (NMOCD Case # 10008 scheduled for hearing November 7, 1990) wherein Hartman has again made several proposals to Chevron to purchase, trade, farm-out or include Chevron's interest so that the proposed enlarged proration unit and acreage can be both fully and efficiently developed.

Based upon the above, it is quite apparent that while both Chevron and Hartman have the same ultimate goal, that being the redevelopment of the Eumont and Jalmat gas pools as a valuable resource to the State of New Mexico, both parties have spent a large amount of time and effort fighting each other rather than applying those very same resources in a more cooperative and productive manner. While we continue to oppose each other's efforts, a well has yet to be drilled and no gas has been produced even though it appears that allowable levels may soon be increased in the Eumont and Jalmat Pools as a result of Texaco's recent Minimum Allowable Hearing for the Eumont Gas Pool.

Therefore it is our desire and request that a meeting be arranged with Chevron and its management whereby we can sit down face-to-face and genuinely and promptly attempt to resolve our pending differences whether it be through a purchase, trade, farm-out, voluntary joinder or any combination of the aforementioned. We believe that by cooperating both parties will be able to go about their business of drilling wells and replacing reserves in a much more efficient manner. By cooperating Chevron USA, Inc. both parties can promptly commence with their proposed drilling activities thereby capturing a portion of the attractive winter gas market demand especially in light of potentially higher allowable rates.

Without such a meeting and subsequent resolution, we feel as an offset operator that we must deny Chevron's waiver request corresponding to the proposed Bell Ramsay (NCT-C) No. 2 well since Chevron continues to insist upon opposing our similar requests for efficient development of our Eumont and Jalmat acreage. To date, Chevron has caused us to waste unnecessary time and energy and may ultimately cause us to drill unnecessary wells in order for us to fully develop our Eumont and Jalmat reserves.

All that we are asking is that both parties take similar and consistent positions as to the further development of their Eumont and Jalmat rights.

Your early attention to this matter is appreciated and again it is requested that we be able to meet with Chevron in the near future so as to resolve our differences. Should Chevron concur please contact Brian Jones or myself so that we can arrange a meeting time convenient to both parties.

Dear Mr. LeMay:

On September 10, 1990 Chevron filed an application with the Oil Conservation Division seeking administrative approval for an unorthodox gas well location for its Gillully "B" Federal Well No. 14 located 1980 feet from the North and West lines of Section 34, Township 20 South, Range 37 East, Lea County, New Mexico and the simultaneous dedication of this well with Chevron's Bell Ramsay (NCT-C) Com. Well No. 1. This unorthodox well location results from Chevron's reentering and recompleting the Gillully "B" Federal Well No. 14 in the Eumont-Yates-Seven Rivers Queen prorated gas pool. The well was plugged and abandoned in 1969.

The Gillully Federal Well No. 14 and the Bell Ramsay (NCT-C) Com. Well No. 1 will be simultaneously dedicated to an existing 480-acre gas proration unit in the Eumont Gas Pool which was approved by the Division by Order No. R-689. Copies of Chevron's application and Order R-689 are enclosed for your easy reference as Exhibits "A" and "B" to this letter.

Chevron provided notice of this application pursuant to OCD Rule 104 to all operators of proration or spacing units offsetting the unit for which the unorthodox location is sought by Certified Mail on September 10, 1990. The only objection to this application was from Doyle Hartman, Oil Operator, who by letter dated September 28, 1990 and copied to William J. LeMay stated that Hartman "conditionally objects" to Chevron's waiver request. Hartman objects not because of any waste or correlative rights consideration, but because of other disputes between Hartman and Chevron, Mr. Hartman also states that unless an agreement can be reached to resolve other differences between Hartman and Chevron unrelated to this case, he will persist in this opposition.

Inasmuch as the proposed unorthodox location does not encroach on any tract owned by Hartman but in fact, is farther away from his tracts than required by OCD Rules (see Plat attached to Chevron's application of September 10, 1990) and since the proration unit involved has previously been approved by the Division, Chevron requests that the Division grant administrative approval to this application, thereby avoiding what will otherwise be an unnecessary hearing before a Division Examiner.


