Gentlemen:

Chevron U.S.A. Inc. respectfully requests your approval of our administrative application for the subject Unorthodox Gas Well Location and Simultaneous Dedication.

We are planning to drill and complete the B. V. Culp (NCT-A) Gas Com. No. 10 in the Eumont Yates 7 Rivers Queen (Prorated Gas) Pool. The proposed location is 840' FNL and 990' FEL, Section 19, T-19-S, R-37-E Lea County, New Mexico. The original well location was proposed for 990' FNL and 990' FEL (standard location) but topographical constraints (road and pipeline) required the drill site to be moved, resulting in the unorthodox location. The location requirements were discussed with Mr. Michael Stogner on September 26, 1990, at which time he instructed us to proceed with seeking administrative approval of this application.

The proposed location is within an existing 477-acre Eumont Gas Proration Unit currently dedicated to the B. V. Culp (NCT-A) Gas Com. Well Nos. 3 and 9 (Order R-6482). We plan to simultaneously dedicate the 477-acres to all three wells.
