This is a request for administrative approval for a non-standard gas well location in the Basin Fruitland Pool.

Meridian Oil intends to plugback and recomplete the Jicarilla 123 C #12 well from the Pictured Cliffs pool to the Basin Fruitland Coal Pool. The current location of this well is 1100'FSL, 1490'FEL, Section 07, T-25-N, R-04-W, Rio Arriba County, New Mexico. The well is considered non-standard due to the NE-SW dedicated pattern established for the Basin Fruitland Coal Pool.
