CNG PRODUCING COMPANY REQUESTS ADMINISTRATIVE APPROVAL OF AN EXCEPTION TO THE FOOTAGE AND LOCATION REQUIREMENTS OF RULE 7, R-8768, FOR THE SUBJECT WELL LOCATED IN THE BASIN FRUITLAND COAL POOL.

THIS REQUEST IS FOR EXCEPTION DUE TO TOPOGRAPHY AND HIGH VISIBILITY (FROM NAVAJO LAKE). A VICINITY MAP, AREA MAP, LAND MAP AND C-102 ARE ATTACHED FOR YOUR REFERENCE.

CNG AND MARIAH ASSOCIATES, INC. (AN ENVIRONMENTAL ASSESSMENT COMPANY) INVESTIGATED THE POSSIBILITY OF A LOCATION AT THREE OTHER SITES. THESE WERE REJECTED BY THE BLM DUE TO THE SEVERITY OF THE TOPOGRAPHY (STEEP SLOPES) AND PROXIMITY TO NAVAJO LAKE (VISUAL CLASS 3). THIS LOCATION IS +/- 3000' FROM THE NEAREST FRUITLAND COAL WELL DRILLED BY CNG AND 507' FROM THE NEAREST OFFSET OPERATED PROPERTY LINE. THE SOUTH HALF OF SECTION 30, T32N, R7W WILL BE DEDICATED TO THIS WELL.

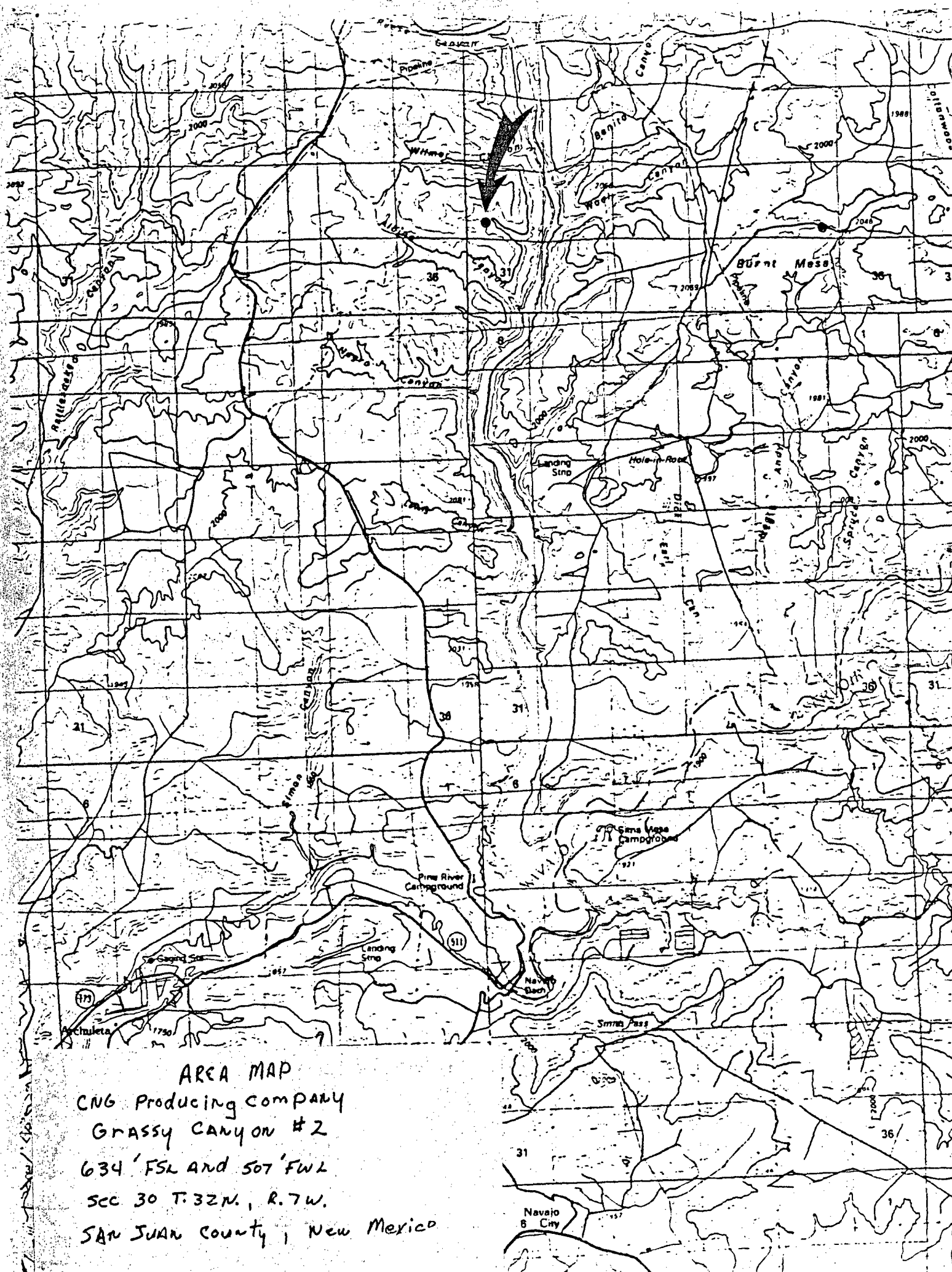

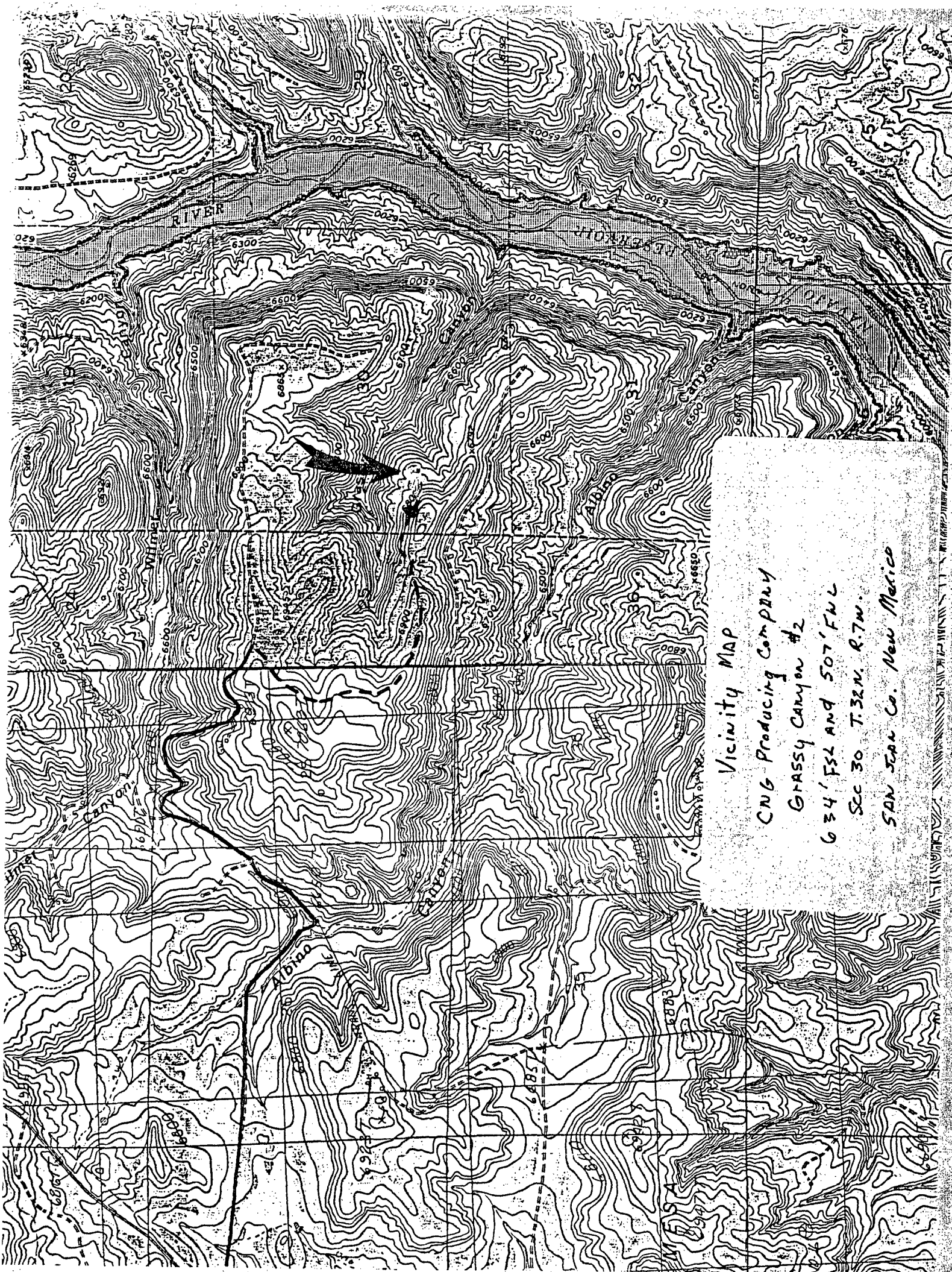

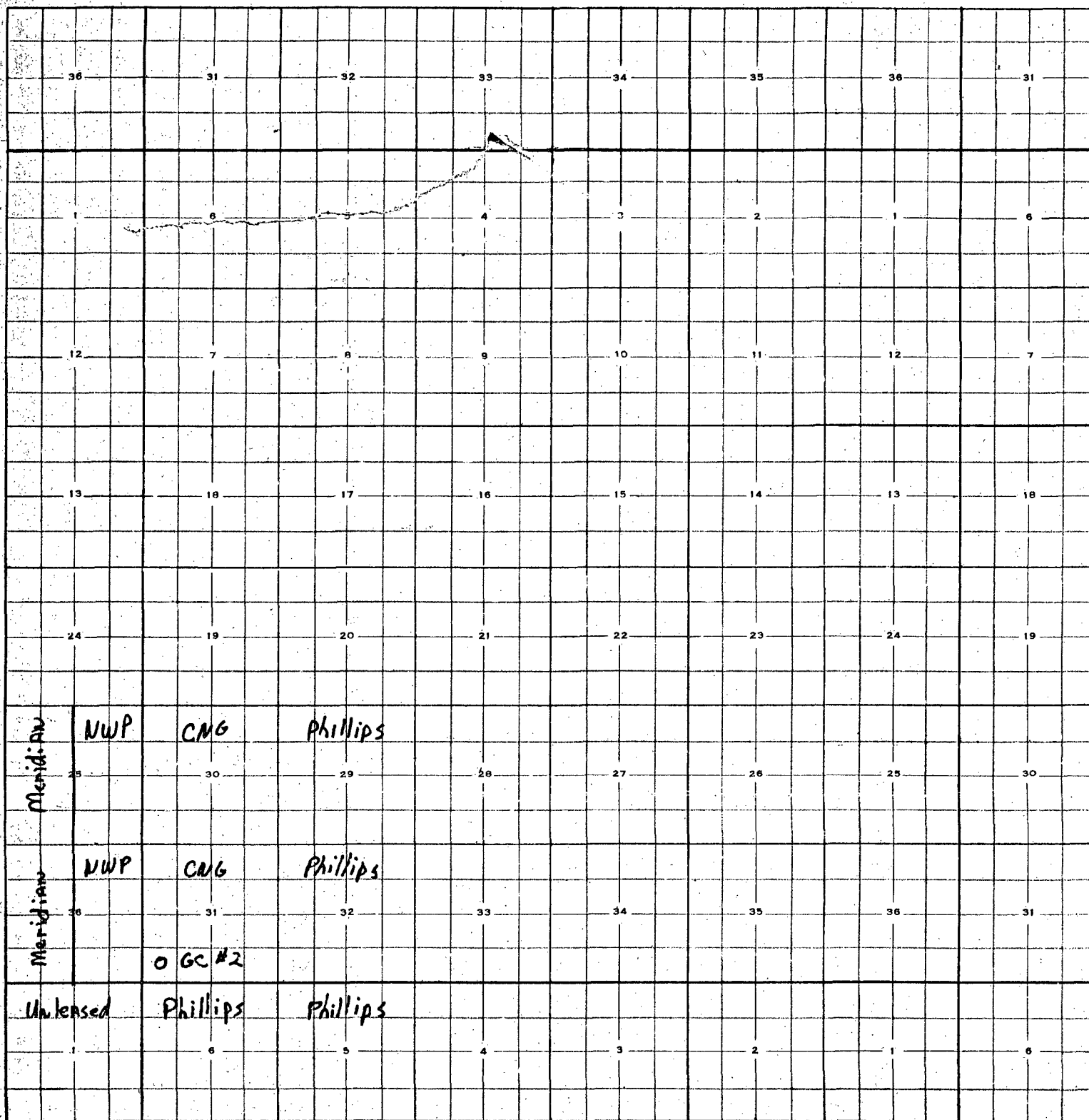
