Dear Messrs. Foppiano, Bohling and Carr:

Please refer to OXY USA Inc.'s letter dated May 2, 1991 objecting to Chevrons USA Inc.'s administrative application for an unorthodox Eumont Gas well location and simultaneous dedication for their Arnott Ramsey (NCT-C) Well No. 5, located in Unit N of Section 21, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico. Said application was filed with the Division on April 1, 1991. Also, refer to Chevron's official response to said May 2nd letter from William F. Carr of Campbell & Black, P.A. of Santa Fe, New Mexico dated May 7, 1991 (see copies of both letters attached).

The subject application was filed by Chevron pursuant to the Special Rules and Regulations for the Eumont Gas Pool, as promulgated by Division Order No. R-8170, as amended. Since all of the requirements under Rule 2(c) of said Special Rules and Regulations were met, Order NSL-3007(SD) was subsequently issued by the Division.

OXY USA Inc., an offset operator, hereby protests the application of Chevron U.S.A Inc. to recomplete its Arnott Ramsay (NCT-C) Well No. 5 in the subject pool and simultaneously dedicate an existing 640 acre proration unit to Well No. 5 and No. 13. Our concern is that this would allow Chevron U.S.A. to produce a 640 acre allowable from a well located 660 feet from our 160 acre Felton unit, which is restricted to a 160 acre top allowable. Such a situation could adversely affect our correlative rights in the Eumont pool, hence our protest. We proposed that Chevron consider some alternative that would address our concerns but have yet to receive a response.

I am attaching a copy of the notice that was sent to OXY regarding the request for administrative approval of their application. Please note that it was sent to OXY's office in Tulsa, Oklahoma, to my attention. Since I don't work in Tulsa and haven't since 1989, I did not receive the notice until almost mid-April. I have notified Chevron to change the address on future mailings.
