Dear Ms. Malik:

Reference is made to your application dated June 14, 1991, for an unorthodox Jalmat gas well location in an existing non-standard 320-acre gas spacing and proration unit (GPU) for said Jalmat Gas Pool comprising the S/2 of Section 17, Township 24 South, Range 37 East, NMPM, Lea County, New Mexico. Said GPU was authorized by Division Order No. R-1527, dated November 17, 1959 and had dedicated thereon the Late Thomas Well No. 1 located 660 feet from the South and West lines (Unit M) of said Section 17.

By Division Orders R-6781, R-6807, NFL-31, and NFL-32, two additional wells, the Late Thomas Well No. 2, located 1980 feet from the South line and 990 feet from the West line (Unit L) of said Section 17, and the Late Thomas Well No. 3, located 1980 feet from the South line and 2080 feet from the East line (Unit J) of said Section 17, were approved for the subject GPU. Authorization was also given in said orders to simultaneously dedicate Jalmat Gas production from the Late Thomas Well Nos. 1, 2, and 3 to the subject GPU.

By authority granted me under the provisions of Rule 2(c) of the Special Rules and Regulations for the Jalmat Gas Pool, as promulgated by Division Order No. R-8170, as amended, the following described well located at an unorthodox gas well location in said Section 17 is hereby approved:



Also, you are hereby authorized to simultaneously dedicate Jalmat Gas production from the Late Thomas Well No. 4 with the Late Thomas Well Nos. 1, 2, and 3. Furthermore, you are hereby permitted to produce the allowable assigned the GPU from all of said wells in any proportion.

All provisions of Division Orders R-1527, R-6781, R-6807, NFL-31, and NFL-31, and NFL-32 shall remain in full force and effect until further notice.
