Dear Ms. Bradfield:

Reference is made to your application dated April 24, 1995 for an non-standard Basin Fruitland coal gas well location for your existing Huerfano Unit Well No. 215 (API No. 30-045-20800) which was drilled in 1971 and completed in the Basin-Dakota Pool at a standard gas well location 1090 feet from the North line and 1840 feet from the West line (Unit C) of Section 9, Township 26 North, Range 10 West, NMPM, San Juan County, New Mexico.

In 1991 the Dakota interval was abandoned and the well was recompleted uphole into the Angels Peak-Gallup Associated Pool as a gas well. By Division Administrative Order NSL-3037, dated August 1, 1991, the location of said well, being unorthodox pursuant to the Special Rules and Regulations for the Angels Peak-Gallup Associated Pool, as promulgated by Division Order No. R-5353, as amended, was approved.

It is our understanding at this time that the Gallup interval will now be plugged back and said well will be recompleted uphole into the Basin Fruitland Coal (Gas) Pool, which pursuant to the Special Rules and Regulations for the Basin-Fruitland Coal (Gas) Pool, as promulgated by Division Order No. R-8768 as amended, is unorthodox. Further, the W/2 of said Section 9 shall be dedicated to the well to form a standard 320-acre gas spacing and proration unit for said pool.

By the authority granted me under the provisions of Rule 8 of said Order No. R-8768, as amended, the above-described unorthodox coal gas well location is hereby approved. Further, the original Division Administrative Order NSL-3037, shall be placed in abeyance until further notice.
