

Describe Cause of Problem and Remedial Action Taken.* Hole in injection line. The plant shut down due to pressure drop. Approximately 90-120 feet of injection line replaced.

Describe Area Affected and Cleanup Action Taken.* Per the NMOCD verbally approved remediation proposal by Basin & Forest, delineation soil samples were collected from the impacted areas, the produced water release site was excavated from the surface to approximately 3 to 4 feet bgs, the impacted soil (approximately 840 cubic yards) was transported to Gandy-Marley Disposal and clean backfill soil transported from Gandy-Marley, back to the site. The excavation was backfilled with the clean transported material and contoured to the original rangeland topography. A BLM Report of Undesirable Event form was completed and emailed to BLM, Carlsbad, NM.






